In support of strengthening student academic achievement, Chattahoochee County School District receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(a)(2) of Every Student Succeeds Act (ESSA). The policy establishes the LEA's expectations and objectives for meaningful parent and family engagement and describes how the LEA will implement a number of specific parent and family engagement activities, and it is incorporated into the LEA's plan submitted to the Georgia Department of Education.

The Chattahoochee County School District agrees to implement the following requirements as outlined by Section 1116:

- The school district will effectively operate programs, activities, and procedures for the engagement of parents and family members in all of its schools with Title I, Part A programs. These programs, activities, and procedures will be planned and operated with meaningful consultation with parents and family members of participating children.
- Consistent with Section 1116, the school district will work with its schools to ensure that the required school-level parent and family engagement policies meet the requirements of Section 1116(b) of the ESSA, and each include as a component a school-parent compact consistent with Section 1116(d) of the ESEA.
- In carrying out the Title I, Part A parent and family engagement requirements to the extent practicable, the school district and its schools will provide full opportunities for the participation of parents with limited English proficiency, limited literacy, disabilities, of migratory children, who are economically disadvantaged, or are of any racial or ethnic minority background, including providing information and school reports required under Section 1111 of the ESSA in an understandable and uniform format including alternative formats upon request and, to the extent practicable, in a language parents understand.
- If the LEA plan for Title I, Part A, developed under Section 1112 of the ESEA, is not satisfactory to the parents of participating children, the school district will submit any parent comments with the plan when the school district submits the plan to the state Department of Education.

• The school district will be governed by the following definition of parental involvement and expects that its Title I schools will carry out programs, activities, and procedures in accordance with this definition in Section 8101 of the ESSA:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- (B) Parents are encouraged to be actively involved in their child's education at school
- (C) Parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child

<u>DESCRIPTION OF HOW THE DISTRICT WILL IMPLEMENT REQUIRED</u> <u>LEA PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS</u>

JOINTLY DEVELOPED

The <u>Chattahoochee County School District</u> will take the following actions to involve parents and family members in jointly developing its LEA plan under Section 1112, and the development of support and improvement plans under paragraphs (1) and (2) of Section 1111(d) of the ESEA:

The district will provide coordination and technical assistance to schools to facilitate parent and family engagement in the planning, review, and improvement of family engagement programs and activities, which include the District and School level Family Engagement Policy, the Consolidated LEA Improvement Plan (CLIP), and School Improvement Plans. The System Director for Federal Programs in coordination with the Parent Engagement Coordinator reviews surveys in the spring and uses results to improve the family engagement program. Building level meetings through the local School Governance Team and the District Parent Advisory Council are held to engage stakeholders in the review and update of annual plans listed above. Ideas and suggestions are researched and discussed with parents, teachers, and administrators. Teachers and administrators are encouraged to review and respond to parent suggestions.

TECHNICAL ASSISTANCE

The <u>Chattahoochee County School District</u> will provide the following coordination, technical assistance, and other support necessary to assist and build capacity of all Title I, Part A schools in planning and implementing effective parent and family involvement activities to improve student academic achievement and school performance, which may include meaningful consultation with employers, business leaders, and philanthropic organizations, or individuals with expertise in effectively engaging parents and family members in education:

Parent Involvement Coordinators are employed to work with Federal Programs to provide coordination, technical assistance, and other support services in planning and implementing effective family engagement. Parent Involvement Coordinators provide assistance at Title I schools by meeting with parents individually and in groups and by providing translation of information when needed. Programming will be coordinated to assist families in transitioning to elementary middle, high, and post-secondary schools or careers.

ANNUAL EVALUATION

The <u>Chattahoochee County School District</u> will take the following actions to conduct, with the meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of this parent and family engagement policy in improving the academic quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The evaluation will also include identifying the needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers and strategies to support successful school and family interactions. The school district will use the findings of the evaluation about its parent and family engagement policy to design evidence-based strategies for more effective parental involvement, and to revise, if necessary, its parent and family engagement policies.

Parents are surveyed annually to determine whether parent engagement needs are being met effectively and appropriately through the implementation of the parent and family engagement programs. Parents are given the option to complete the survey electronically. The results of these surveys are used to develop strategies for school improvement and to revise the district and school Parent and Family Engagement Policies. These results are also used in planning future parent workshops and meetings. Areas evaluated include academics and school leadership, parent involvement, Title I, school environment, and the school Parent and Family Engagement Program.

RESERVATION OF FUNDS

The <u>Chattahoochee County School District</u> will involve the parents and family members of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent and will ensure that not less than 90 percent of the 1 percent reserved goes directly to Title I schools.

Each Parent and Family Engagement Coordinator offers each parent the opportunity to give feedback on the 1% reservation of funds by surveying parents on the use of funds. During the Annual Title I meeting and in the quarterly local school governance team meeting, the school will share the budget to accept feedback regarding the parent and family engagement activities

COORDINATION OF SERVICES

The <u>Chattahoochee County School District</u> will coordinate and integrate parent and family engagement strategies, to the extent feasible and appropriate, with other relevant Federal, State, and local laws and programs: *Chattahoochee County Head Start and Pre-Kindergarten* that encourage and support parents in more fully participating in the education of their children by:

Chattahoochee County Schools will coordinate with Head Start and Pre-Kindergartens to facilitate a smooth transition for both parents and students from these programs to Chattahoochee County School by working collaboratively with these outside agencies. The district will also provide transition services for K-8th grades through the Open House forum so each parent has the opportunity to connect with the student's advisor, homeroom teacher, and the student schedule. Multiple wrap-around service providers and community partners provide access to resources to assist in the transition of elementary and middle school students with a Back to School Bash and ongoing annual activities for the community and parents.

BUILDING CAPACITY OF PARENTS

The <u>Chattahoochee County School District</u> will, with the assistance of its Title I schools, build parents' capacity for strong parental involvement by providing materials and training on such topics as literacy training and using technology (including education about the harms of copyright piracy) to help parents work with their children to improve their children's academic achievement. Assistance will also be provided to parents in understanding the following topics:

- The challenging State academic standards
- The State and local academic assessments including alternate assessments
- The requirements of Title I, Part A
- How to monitor their child's progress
- How to work with educators

Title I schools will offer computer access to parents in the computer lab at both the Chattahoochee County Elementary and Middle Schools, to aid in their knowledge and use of technology specifically to assist parents in navigating the PowerSchool student information system. Chattahoochee County Schools will provide tips and ideas to parents on helping their children with core content subject areas. Parents are given the opportunity to check out a wide variety of resource materials from the Parent Resource Centers to use at home with their children. Additionally, parent friendly videos are available and posted to provide ease in access to information and how to navigate specific platforms and programs used by students.

BUILDING CAPACITY OF SCHOOL STAFF

The <u>Chattahoochee County School District</u> will, with the assistance of its schools and parents, educate its teachers, specialized instructional support personnel, principals, and other school leaders, and other staff in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and schools by:

- Having video discussions based on videos about engaging families.
- Creating opportunities for Staff to discuss barriers to Family Engagement.
- Using Class Dojo for meaningful two-way communication directly with families daily.
- Using Facebook, the school website, the school app, phone calls, and flyers to keep families informed of opportunities to be engaged.
- Attending Professional Development trainings with the Parent Engagement Coordinator.
- Sending out tips and strategies on ways to communicate with and involve families in the academic success of their students.
