

HANCOCK COUNTY SCHOOLS PARENT INVOLVEMENT POLICY

PART I. GENERAL EXPECTATIONS [Section J 118(a)(2), ESEA.]

The school agrees to implement the following statutory requirements as part of its Parental Involvement Policy:

- the State's student academic achievement standards,

- the State and local academic assessments including alternate assessments,

- · how to monitor their child's progress, and
- how to work with educators: The school will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement. Through the use of LiveGrades, parents will have the opportunity to use this technology as an additional way to keep them updated on their children's academic progress. In addition, the Title I teachers, through the Family Literacy Action Group (FLAG), will work with parents during the school year. The teachers will assist/instruct parents on varying methods to help children and provide educational materials. The school will, with the assistance of its parents, educate its teachers, central office personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.

Through presentations during in-service days and/or staff meetings/LSIC meetings, Title I teachers will present a program lo the school staff on varying methods of building partnerships between home and school.

The schools will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with county collaborative preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

Pre-K to kindergarten transition programs will be presented at school. Parents of all Pre-K students will be invited to attend. Hancock County preschool collaborative programs will be invited to FLAG parental involvement activities when appropriate.

The school will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and to the extent practicable, in a language the parents can understand.

Through the use of Google translator, correspondence to parents of EL students will be sent home in English and in their native language. Parents of EL students will also be invited to all FLAG meetings held throughout the year. In addition, Title I staff will endeavor to keep correspondence with Title I parents clear and educational-jargon-free. PART II. DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED PARENTAL INVOLVEMENT POLICY COMPONENTS

- The school will take the following actions to involve parents in the joint development of its parental

 gather data and opinions. Form an Advisory Committee of parents who showed an interest by
 responding to a survey question. Consider comments on the parents' evaluation of F.L.A.G.
 meetings.

individuals/groups. Strengths and weaknesses will be addressed as well as ideas shared on ways to implement improvement steps.

- The school will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies in our preschool collaborative programs.
- Invite pre-kindergarten children and their parents to one appropriate program to help them transition to our school.

The school will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of the school. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). In early Fall, an opinion survey will be conducted among parents of Title I students. The most senior Title I teacher in the school will be responsible for compiling the information for the PEA Parent Involvement Coordinator and the Title I Director. An end-of-the-year survey will provide further evaluation.

FLAG (Family Literacy Action Group) is a vital component of Hancock County School's parent involvement program. FLAG programs focus on providing parents with information on child development and child rearing. These programs will also provide practical strategies parents can apply at home to better help their children with reading and math skills.

The FLAG program consists of four evening parent sessions. At least one of these four meetings are countywide. The first of these will be in the beginning of the year "Kick-Off meeting". This meeting will introduce parents to our county's Title I program. In addition, individual schools will provide parents with packets containing pertinent information about the Title program (including parent surveys, tutoring opportunities, summer school, etc.) in that school. The countywide meeting will be held in the spring. During the school year, two more meetings will be held locally, each stressing FLAG's focus components. Parent Survey results will be reviewed and utilized to plan FLAG programs.

The Hancock County Title I staff will coordinate and join talents in designing and implementing the FLAG program with special attention given to parent concerns and suggestions. Meeting format will generally include activities and grouping that involves parents, children, and parents working with their children. Outside presenters may also be included. Families will share refreshments and each child will be given a gift book at the meeting.

The following students/families will be included in our FLAG programs:

Title 1 students in K-4

- Title I tutored students in grade K- 4
- Title I private/parochial students
- Final meeting—Collaborative preschool students registered in kindergarten for the coming Fall.

PART IV. ADOPTION

The Hancock County Schools Parental Involvement Policy has been developed jointly with, and agreed on with, parents of children participating in Title I, Part A programs, as evidenced by the agenda, notes, and signatures from the collaborative meeting.
