All ODY Students Receive FREE Breakfast and Lunch Meals at School for 23-24

The Owen D. Young Central School District recently qualified for the Community Eligibility Provision (CEP), which means that ALL students will receive FREE breakfast and lunch at school for the 2023-24 school year. The district received this designation based on different factors that revealed the need for financial assistance for district families.

"This will benefit our entire district and help alleviate some of the financial pressure that our families are feeling," Superintendent of Schools Brennan Fahey said.

The CEP provision does NOT cover the costs of any additional a la carte items (milk, yogurt, ice cream, cookies, etc.) that your student may want to purchase in the cafeteria. Students can either pay for these items in cash, or pay through a digital EZSchoolPay account, which must have a positive account balance in order to use it.

To add funds to your student's account, you can pay by check (made out to OHM BOCES Food Service), make an online payment (https://www.ezschoolpay.com), or send cash in with your student in a labeled envelope.

"In order to receive the appropriate aid that our school deserves and needs, it is critical that our families continue to fill out an income form annually," Fahey said. "Even in a year where students receive free meals, there are many other benefits for households that meet certain income thresholds."

Annual notifications and important announcements

Notice of Residency

The district has a policy for student residents that, according to education law, entitles them to attend public schools maintained in the district in which they reside. The district also has a non-resident policy that allows students who do not legally reside in the district to be approved for attendance in the district's school under certain conditions.

Families of non-resident students must submit a request in writing to the Superintendent. Enrollment determination will be made in the best interest of the District and the student, taking into consideration the student's academic, disciplinary and attendance records. Tuition will be determined each year at the re-organization meeting.

Parent Notification Regarding Teacher Qualifications

In accordance with the federal No Child Left Behind Act of 2001, parents and guardians have the right to request specific information about the professional qualifications of their children's classroom teachers. As a parent/guardian of a student in the Owen D. Young Central School District, you have the right to request the following information:

- If the teacher has met New York State qualifications and licensing criteria for the grade levels and subject areas he or she teaches;
- Whether the teacher is teaching under emergency or other provisional status for which the state qualification or licensing criteria have been waived;
- The teacher's college major, whether the teacher has any advanced degrees and, if so, the subject of the degrees; and
- If your child is provided services by any instructional aides, if similar paraprofessionals provide services to your child and, if they do, their qualifications.

Data Privacy and Security

The Owen D. Young Central School District seeks to use current technology, including electronic storage, retrieval, and analysis of information about students' education experience in the District to enhance the opportunities for learning and to increase the efficiency of our district and school operations. The Owen D. Young Central School District seeks to insure that parents have information about how the District stores, retrieves, and uses information about students, and meets all legal requirements for maintaining the privacy and security of protected student data and protected principal and teacher data, including Section 2-d of the New York State Education Law. To further these goals, the Owen D. Young Central School District has posted this Parents' Bill of Rights for Data Privacy and Security:

- 1. A student's personally identifiable information cannot be sold or released for any commercial purposes.
- 2. Parents have the right to inspect and review the complete contents of their child's education record. The procedures for exercising this right can be found in Board Policy #7240, Students Records Access and Challenge. You may access this Policy from the District's website.
- State and federal laws protect the confidentiality of personally identifiable information and safeguards associated with industry standards and best practices, including but not limited to encryption, and firewalls. Password protection must be in place when data is stored or transferred.
- 4. A complete list of all student data elements collected by the State is available at http://www.p12.nysed.gov/irs/ sirs/documentation/NYSEDstudentData.xlsx and a copy may be obtained by writing to the Office of Information & Reporting Services, New York State Education Department,

- Parents have the right to have complaints about possible breaches of student data addressed. Complaints should be directed in writing to the Chief Privacy Officer, New York State Education Department, Room 863 EBA, 89 Washington Avenue, Albany, New York 12234.

* Supplemental Information About Third Party Contracts: In order to meet 21st century expectations for effective education and efficient operation, the District utilizes several products and services that involve third party contractors receiving access to student data, or principal or teacher data, protected by Section 2-d of the Education Law. The District recognizes that students, parents, and the school community have a legitimate interest in understanding which of the District's vendors receive that data, for what purpose, and under what conditions. The District has undertaken the task of compiling that information, and of insuring that each new contract adequately describes (1) the exclusive

purposes for which the data will be used, (2) how the contractor will ensure that any subcontractors it uses will abide by data protection and security requirements, (3) when the contract expires and what happens to the data at that time, (4) if and how an affected party can if and how an affected party can challenge the accuracy of the data is collected, (5) where the data will be stored, and (6) the security protections taken to ensure the data will be protected, including whether the data will be encrypted.

Asbestos Notification

Federal regulations require that schools be inspected for the presence of asbestos, a potentially toxic material that has been used in the construction industry for years. The Owen D. Young Central School District buildings have been inspected for asbestos containing-materials. The results of these inspections are contained in the Asbestos Management Plan. The state authority in charge of asbestos has approved this plan.

The Asbestos Management Plan includes the results of all the inspections conducted on all district buildings. It also contains the results of the material samples which were taken during the inspections and the records of any damage or removals.

The Asbestos Management Plan is available for review during regular working hours at the school office. On request, a copy of the plan will be made for a nominal fee to cover the costs of copying and handling.

Title 1 Complaint Procedure

Any school parent or teacher or other interested person or agency may file a complaint concerning violations of ESEA Title 1, Parts A, C, and D, or of the General Education Provisions Act, or of Section 100.2(ee) Academic Interventions Services of the Regulations of the Commissioner.

- Be written:
- Be signed by the person or agency representative filing the complaint;
- Specify the requirement of law or regulation being violated and the related issue and/or the concern;
- Contain information/evidence supporting the complaint;
- State the nature of the corrective action desired.

Harassment and Discrimination Are Prohibited At School

The Dignity for All Students Act is a state law that went into effect July 1, 2012. The intent of the law is to provide all public school students with an environment free from discrimination, bullying, and harassment, as well as to foster civility in public schools. The Dignity Act also focuses on prevention of harassment, bullying and discriminatory behaviors through the promotion of educational measures meant to positively impact school culture and climate, including instruction in safe, responsible use of the Internet and electronic communications.

In plain language, students should understand that:

You should never feel that it is not safe to come to school and participate in all school activities. You should never be prevented from concentrating on your schoolwork because another student or a school staff member is teasing you, making fun of you, pushing you around, or threatening you in some way because of your race, color, weight, national origin (where your family comes from), ethnic group, religion, religious practices, disability, sexual orientation, gender, or for any other reason.

A student may not act toward another student in a way that reasonably might make that other student feel threatened or unsafe or that might reasonably make that other student unable to concentrate on school work because of the other student's race, color, weight, national origin, ethnic group, religion, religious practices, disability, sexual orientation, gender, or for any other reason. It is against school rules for any student or school staff member to do this by physical actions or by verbal statements, including electronic messages. This kind of conduct is prohibited on school property, on school buses, and at all school-sponsored events.

Changes to the law effective July 1, 2013, include specific information prohibiting harassment, discrimination and bullying, including cyber-bullying, and require school administrators to take action regarding conduct that may take place off school property when that behavior creates or would foresee-ably create a risk of substantial disruption within the school environment, and/or where it is foreseeable that the conduct, threats, intimidation or abuse might reach school property. This is to serve as a reminder that we consider the safety of our students extremely important.


Integrated Pest Management

The Owen D. Young Central School District uses current Integrated Pest Management Practice to reduce the use of pesticides in our building and on our grounds. It may be necessary to use pesticides periodically during the school year. New York State law requires that schools maintain a list of persons in

parental relation, faculty, and staff who wish to receive 48-hour prior written notice of certain pesticide applications. The following pesticide applications are not subject to prior notification requirements:

- Anti-microbial products
- Nonvolatile rodenticides in tamper-resistant bait stations in areas inaccessible to children
- Nonvolatile insecticidal baits in tamper-resistant bait stations in areas inaccessible to children
- Silica gel and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children
- Boric acid and disodium octaborate tetrahydrate
- The application of EPA-designated biopesticides
- The application of EPA-designated exempt materials under 40 CFR §152.25
- The use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

In addition, there will be no written notice of such application when a school remains unoccupied for a continuous 72 hours following an application. In the event of an emergency application necessary to protect against an imminent threat to human health, a good-faith effort will be made to supply written notification to those on the 48-hour prior notification list. If you would like to receive 48-hour prior notification of pesticide applications that are scheduled to occur in the school, please send a letter requesting such. Be sure to include your name, day and night-time phone numbers, and your complete address. Send this information to the main office at PO Box 125, Van Hornesville, NY 13475. Student Accident Insurance

Owen D. Young Central School District carries student accident insurance through Commercial Travelers Mutual Insurance Company. Students are covered while on route to and from school, during school session and during practice or play of interscholastic sporting events. Should your child become injured, the proper forms may be obtained from the nurse's office. Upon completion, the forms are submitted through the school Business Office.

Updates on the capital project work

Major progress was made this summer on the district's \$3.5 million capital project which was approved by voters in November, 2021. With no tax levy impact, the project is being supported through state aid, and funds from the district's Capital Reserve Fund. The project boasts key infrastructure updates and enhanced learning environments including:

- All new STEAM Suite in the technology/art wing, featuring a welding simulator, paint room, agriculture room and shop room.
- Brand new elementary classroom in the ground level space previously used as a pool changing room.
- Replacement of boilers, pumps, piping, controls and HVAC units, with more modern units with more efficient heating and air circulation.
- · All new office suite near the cafeteria, with space for Ms. Soper (guidance), Mrs. Tucker (asst. principal), Mrs. Dieffenbacher (psychologist), and Mrs. Jones (guidance secretary/BOE clerk).
- An "Engineering by Design" room in the former sixth grade classroom to enhance the STEAM program (Science, Technology, Engineering, Arts, Mathematics). Stay informed on the progress of this capital project on the District website.

Electronic Surveillance

Owen D. Young CSD uses video equipment to assist in building and transportation safety and security. Cameras are placed at entrances and hallways, both inside and outside of the building. There are also cameras on school-owned buses. The purpose of the cameras is primarily building security and safety, but students and parents must be informed that the video footage is sometimes scanned in situations where incidents involving students may have happened. If the camera footage indicates that a child has misbehaved in any way, administration will use those image to give consequences, as necessary.
