3. Credit allowed for all verified experience as authorized by Board Policy. Verification of experience and training must be submitted to the Human Resource Department no later than October 1, to be reflected on contracts for the 2024-2025 school year.
4. This is a one year document that reflects placement only. Future movement will be determined by the Legislative funding allocation.
5. Notwithstanding anything to the contrary set forth herein, if funding is withdrawn or reduced during the fiscal year due to insufficiency of appropriations, the Board or school district shall be entitled to reduce the salary and benefits in order to address funding deficiency and avoid deficit spending.
