



## Putnam County High School Athletic Hall of Fame Guidelines for Nomination & Election

### Purpose

The purpose of the Putnam County High School (PCHS) Athletic Hall of Fame is to recognize and honor those former athletes, coaches, administrators, and community supporters who excelled in their respective sports or coaching/supporting roles and who helped bring honor, recognition, distinction, and excellence to PCHS by their conduct. This recognition will help maintain the spirit, pride, and sense of community as well as serving as a historical account of the great athletic tradition of PCHS.

### Eligibility for Nominations

Athletes are eligible for nomination 10 years after their class's graduation. They must be in good standing or in special circumstances as determined by the hall of fame committee. Such athletes must have competed in an IHSA-sanctioned varsity sport in which he/she excelled. Among the accomplishments taken into account will be individual (All State/All Conference/All Area/Coaches Association/performance at the state series), team accomplishments, individual school and/or team records held, and impact on teams and the overall athletic program at PCHS during their era.

Nomination is also open to coaches and administrators. Coaches and administrators are eligible for nomination five (5) years after they've completed their eighth (8) year of coaching/administration at PCHS or by special circumstances as determined by the committee. These individuals must have participated with distinction and/or made significant contributions to athletics at PCHS, as evidenced, by the success of their teams and/or the acknowledgment of the impact they had by their former student-athletes.

### Nomination Process

A candidate may be nominated for Hall of Fame membership by any member of the community. Formal nomination shall be made using the nomination form that is available on the Putnam County website. The nomination form must be received by the athletic department by October 1<sup>st</sup>. All applications are to remain confidential, only to be shared among the committee members. **Information relating to the nominee's career statistics, records, and achievements must be supported by cited sources so that the information may be verified. Individuals must supply any and all documentation when submitting a nomination form.** Once presented as an eligible nominee, a candidate who is not elected shall automatically be reconsidered annually until he/she has been considered for five (5) years. Thereafter, re-nomination may occur at any time. The nominations will be evaluated using the following criteria:

Exemplary achievements and recognition in their chosen field

- Outstanding citizenship
- Exhibit qualities of leadership
- Has made meritorious contributions to society
- The candidate must demonstrate the qualities listed above in a manner that will inspire the students of PCHS in the pursuit of excellence.

The Hall of Fame Committee is comprised of high school administration, current and former coaches, and established members of the community. The committee will meet in October/November to review the nominations. The Hall of Fame Class will be announced in December. Hall of Fame Night will take place at a home basketball game. The actual date will vary but will be communicated by the athletic department.
