

# NEWFIELD CENTRAL SCHOOL DISTRICT BUDGET NEWSLETTER



## 2024-2025

Dear Neighbor,

Why is the school asking you to come vote again? Because this is Newfield's school and this is what local control looks like in public education. School districts hold votes in order to ensure that their taxpayers approve the financial decisions the district makes in order to attain its goals. Local control is further gained by the community's election of Boards of Education to ensure that the public's interests are represented in the board's fiscal and fundamental oversight of the district. Be a part of Newfield's democracy by casting your ballot in what you want your school to be!

Description of what you will see on the ballot:

**Board of Education Election –** 2 seats, each for 3-year terms.

**Prop 1) 2024-25 Budget** – Authorizes spending of \$25,482,411. About 70% is funded by state aid and other sources, and about 30% by the Newfield school tax levy. The tax levy would increase 3.5% compared to last year. **Prop 2) New Vehicle Purchases** – Authorizes the district to buy 2 new vehicles: 1 passenger van and 1 bus at a total cost to the voters of no more than \$233,750. This expense is built into the budget in Proposition 1. Purchase of an electric bus would be contingent on rebates/grants – if they are not available, a diesel bus would be purchased instead.

**Prop 3) 2024 Capital Reserve Fund** – This establishes an account where the district can start saving funds for a future project. The district's previous reserve fund has ended because a capital project has begun. **Prop 4) Library Tax** – This is not a school tax. The school district collects this tax on behalf of the Newfield Public Library. NPL currently receives \$76,000 per year. They are asking for an increase of \$5,000, which is about an additional 1 penny per \$1,000 of assessed property value.

The proposed 2024-25 budget was created to support the District's Mission, which is to "Support a healthy, thriving community by nourishing the minds and bodies of every generation of students, thus Educating and Empowering them to navigate their futures." Our mission supports our vision: "The Vision of the Newfield CSD is to create a safe and equitable environment, inspiring community-minded students who embrace learning and compassion."

This budget also includes start-up funding for a new program – a preschool special education class called a "Special Class in an Integrated Setting." The SCIS would serve 3-5-year-old Newfield residents, with and without special educational needs. Currently, these students travel significant distances to receive services or must wait until placements are available, due to a lack of providers in the County. Opening this program will help our community and help our youngest learners get all the support they need to thrive here in Newfield. After the start-up costs, the program will save the district money that is currently going to other organizations, and bring in more revenue from the state for many of the services. We also hope that this program will help increase student enrollment by opening more spots up in the Pre-K program and by offering more services and early interventions for students with special needs, thus keeping families in the district.

With that being said, we urge you to take time out of your busy schedules to ask questions, learn as much as you can about the items and people on the ballot, and come out to make an informed vote. And, for the long line of people waiting in their cars for dismissal every day, please park and come in to vote. It is important that our community has as many of the eligible voters as possible come to the polls to make their voices heard.

## What's new in the 2024-25 budget?

The district is on an improving trend when it comes to its finances. As you'll see in the chart to the right, the combination of COVID-related expenses, the high rate of inflation, and the historic overutilization of our savings had a serious impact on the district. The chart on the right shows our State Comptroller Fiscal Stress scores since 2017. With the changes we have made, we are optimistic that we will return to "No Designation" status next year.

## Educational Investments 24-25

- With federal grants ending, this budget continues the Reading Specialist and Teaching Assistant positions that help our students succeed.
- We are adding a preschool special education program that will provide early intervention to students right here in our community, and bring in additional funds as well.
- We are keeping the small class sizes, excellent fine arts programs, and career education opportunities that make Newfield special.

## **CAPITAL OUTLAY PROJECT**

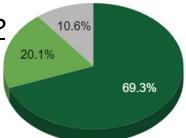
Again this year, the district will undertake a capital outlay project. The State will reimburse Newfield for approximately 88% of the project. Outlay projects are capped by the state at \$100,000.

The 2024-2025 capital outlay project will consist of door and security access upgrades throughout the district's buildings.

# How will the school's money be spent next year?

NYS requires all school districts to present our budgeted expenses in three parts:

- **Program**, including expenses related to students and their needs
- Capital, expenses for the operation and maintenance of the facility
- <u>Administration</u>, expenses related to management and overall support of the district.

## **PROGRAM**

This section of the budget refers to all expenses related to students and their needs. Examples include educational programs, transportation, athletics, and extracurricular activities, as well as teacher salaries and employee benefits.

Proposed changes this year are due to additional funding for retirement costs, a new preschool special education class, keeping teachers who used to be under grants, increases of expenses in special education and occupational education, as well as health and fringe benefit costs increasing. Overall, a proposed total increase of \$1,433,137 from last year.

## **CAPITAL**

Next, we'll take a look at the capital portion of the budget. This deals with all equipment, supplies, materials and personnel for the operation and maintenance of the district. It also includes all payments on principal and interest on short and long-term debt.

Proposed changes this year are due to increases in cleaning and maintenance salaries and benefits, and new equipment purchases to maintain our facilities - however these are all offset by a decrease in our debt expenses. Overall, a proposed total decrease of \$666,487 from last year.

## **ADMINISTRATION**

The third and final portion of the budget is administration, which relates to expenses for management and overall support of the district. Examples include Board of Education expenses, central administration, building administration, business office, legal fees and auditing services.

Proposed changes this year are due to additional funding for potential legal fees, retirement costs, additional business and administrative costs at BOCES, a newly created curriculum development position, salary increases in several administrative positions and related increases to health and fringe benefits. Overall, a proposed total increase of \$214,589 from last year.

## Revenue - where will the school district get money from next year?

The funds that operate the district come from a variety of sources. The largest, at about 65% of our revenue, is NY State aid. Next is local taxes, at about 29%. Then we have "Other", a miscellaneous category that includes rental of our spaces, refunded payments, interest income on our bank accounts, etc. This is about 4.5% of the budget. And finally, there is Fund Balance, which is the amount we have saved this year for use next year, at about 1.5%.

State Aid for next year increased slightly - we have seen much larger increases in years past. With declining enrollment, and the state looking to slow down or even reduce education funding, we unfortunately may need to expect this trend to continue.

The Tax Levy is our second largest revenue source. This levy is limited by a tax cap restriction. Schools that exceed the restriction must have a 60% approval rate in order to pass the budget. Our tax cap restriction from 2024-2025 was set at 4.31%. However, our 2024-2025 proposed tax levy is \$7,432,413, representing a 3.5% tax levy increase and falling within the tax cap restriction. Our tax rate will fall from 17.02 per 1000 assessed value to 16.44 per 1000 of assessed value. More on taxes in our next section.

You may notice an increase in the use of Fund Balance in the 2024-2025 revenue budget. These are savings from the previous budget year, and are primarily being applied to cover the start-up costs of a preschool education program that will begin to generate its own revenue once it gets up and running. With other anticipated increases such as interest earnings, we expect not to use this much fund balance in future years.

Revenues in the "other" category have increased as well, primarily due to interest earned on money invested, refunds from BOCES for any unexpended money at year-end, and Medicaid funds for students who receive qualifying special services.



## **School Taxes**

While it's not the largest source of funds for the district, the district's Tax Levy is the funding source that most directly affects our community. And it's not the simplest system, so hopefully a little explanation will help. First, there are three key terms that come up:

- Tax Levy the total amount of funds from taxpayers that go to the school in a year
- Assessed property values these are determined by the county assessor(s)
  - Total assessed value the combined values of all the Newfield School taxpayers
  - Individual assessed value the value of your property specifically
- Tax rate the Tax Levy divided by the Total assessed value gives you the Tax Rate



The Tax Rate determines how the school's funding is shared across the community, and it can be confusing, so let's use an example most of us will be familiar with - gasoline. If we all go to the same gas station at the same time, we all pay the same rate for gas per gallon. However, if I have a bigger gas tank than you do, I'm going to pay more than you in total, even though we paid the same rate. That is similar to how it works with school taxes, where the rate is the same for everyone but not everyone pays the same total amount. Instead of using the size of your gas tank, we use the value of your home or business property. The more valuable your property is, the bigger your tank is, and the more you pay in total school tax.

This year, the Tax Levy is going up 3.5%. In addition, many of your individual assessments have gone up as well. Because of this, the Tax Rate is expected to go down to 16.44 per \$1,000 of assessed value (from 17.02 last year). How does this impact the actual taxes you pay? It may go up, it may even go down - confused yet? Here is a chart showing some hypothetical situations that may help.

## **VOTING INFORMATION**

Pursuant to the Education Law, Section 2013, and by resolution of the Board of Education, voting on the 2024-2025 Budget Proposition, Vehicle Purchase Proposition, 2024 Capital Reserve Fund Proposition, Library Tax Levy Proposition, and election of **two (2)** Board Members will be held Tuesday, May 21, 2024, between the hours of 12:00 Noon and 9:00 P.M. prevailing time at Newfield Elementary School, Lower Gym, 247 Main Street, Newfield New York at which time the polls will be open to voting by ballot or machine.

## QUALIFICATIONS TO VOTE:

To vote in a school district budget vote and board election, you do not need to be a registered voter, however, you must:

- \*Be a citizen of the United States;
- \*Be 18 years of age or older;
- \*Be a resident within the district for a period of 30 days preceding the date of the vote.

No person shall have the right to register for, or vote, at any school meeting or election who would not be qualified to register for or vote at an election in accordance with the provisions of Section 5 - 106 of the Election Law. (This includes convicted felons and those adjudged mentally incompetent by a court).

## **VOTING BY ABSENTEE BALLOT:**

Applications must be received no later than (7) seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be picked up personally by the voter. Any absentee ballot received after 5:00 PM on 5/21/24 can not be accepted.

## ON THE 2024-2025 BALLOTT:

#### **PROPOSITION 1:**

Shall the Board of Education of the Newfield Central School District be authorized to spend \$25,482,411 for the purpose of operating the school district for the 2024-2025 school year and to levy the necessary tax thereafter?

#### **PROPOSITION 2:**

#### **Vehicle Purchase**

Resolved that the Board of Education of the Newfield Central School District is hereby authorized to undertake the acquisition of one van, at an estimated maximum cost of \$51,000, and either one electric school bus, with charging station, or one diesel school bus, at an estimated initial maximum acquisition cost of \$505,000, but with an estimated net maximum cost in either case of \$182,750 after the receipt of acquisition and infrastructure grants, if applicable, and bus trade-in value, if any; and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district not to exceed \$556,000, or so much as may be necessary, shall be issued. The actual expense to the taxpayer will not exceed \$233,750 combined expense for the bus and van.

#### **PROPOSITION 3:**

## 2024 Capital Reserve Fund

Resolved, the Board of Education of the Newfield Central School District is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law to be designated, "2024 Capital Reserve Fund" created to defray the cost of the construction, reconstruction and equipping of School District buildings, facilities, and land, including original equipment, machinery, apparatus, appurtenances, furnishings, land acquisitions, and other incidental improvements and expenses in connection therewith, and in order to accomplish the same, the Board is hereby authorized to establish the ultimate amount of such reserve fund to Five Million Dollars (\$5,000,000) inclusive of accrued interest and other investment earnings, with a probable term of ten (10) years. The Board of Education is hereby authorized to pay funds from the available fund balance, state aid reimbursement to the School District on account of capital projects, such other monies as the voters may direct, and/or other legally available funds of the School District to such reserve fund in an amount determined by the Board of Education up to the maximum authorized amount.

#### **PROPOSITION 4:**

## **Library Tax Levy**

Shall the proposition be approved authorizing the Board of Education of Newfield School District to increase the tax levy from seventy-six thousand dollars (\$76,000) to the sum of eighty-one thousand dollars (\$81,000) and shall such sum be paid annually to the Trustees of the Newfield Public Library.
