Allyson Pitts	Health and Wellness / SSD Counseling	District Updates Health Center Mental Health Counselors	Jacket Health and Wellness is year 4 of the 5-year grant cycle. We are working on sustainability so that at the end of the grant, Mainline will be able to continue its services. As of Sept. 13, 2023, 348 patients were seen. 51 students were transported to the clinic, mostly from the middle school. Working to increase numbers at the East End site School Counselors have seen 826 students so far this year to address their individual needs. The high school counselors are seeking programs to assist them in pushing into the classroom to support students. School-Based Mental Health- At the end of the 4th quarter, Pinnacle Pointe had 483 students enrolled and they have provided 4012 sessions with students across the district during the 4th quarter

			Our district Social Worker, Quisha Gibson, is working to support students within the schools. Nurses- As of September 25, 2023, the nurses have completed 5,029 office visits. They are currently preparing for flu clinics on each campus.
