

## GCR-1 Track Repair and Resurface Project

The Gasconade Co R-1 School District is currently seeking bids for the repair and respraying of the athletic track and runway areas at Hermann High School, located at 176 Bearcat Crossing Hermann, MO 65041.

Contractors are asked to submit bids by 9:00 AM, Monday, March 8, 2024 to Gasconade Co R-1 School District located at 170 Blue Pride Dr. Hermann, MO 65041 (Attn: Dustin Hoener). Bids must be sealed and plainly marked: "Track repair and resurface".

Base bid scope of work:

Cleaning, crack repair, and respraying/stripping the rubber surfaces on the track and field areas.

Specifications/Details include:

1. Install a minimum 2mm red polyurethane structural spray coating
2. Track striping per NFHS standards to match existing layout
3. Repair surface cracks
4. Include 5-year warranty for polyurethane structural spray
5. Include 1-year warranty for track striping
6. Site visits are strongly encouraged to see conditions of surface

Alternate bid scope of work:

1. Install 11mm black mat system on existing asphalt d-zone
2. Install 2mm red polyurethane structural spray coating
3. Install anchor system for high jump mats
4. Include asphalt repairs in price
5. Include 5-year warranty

Bidders may submit alternative solutions for consideration.

*Addenda:*

*If specifications or terms are revised, the District will issue an addendum addressing the nature of the change. Offerors must sign it and include it in the returned proposal package*

*Award:*

*The District reserves the right to award this contract on the basis of LOWEST OR BEST OFFER in accordance with the laws of the State of Missouri, to waive any formality or irregularity and to reject any or all proposals.*

*Assignment:*

*The successful offer may not assign, sell, or otherwise transfer this contract without written permission of the District.*

*Termination:*

*The District reserves the right to terminate the contract for default if there are any breaches of the terms therein, including warranties of offeror or if the offeror becomes insolvent or commits acts of bankruptcy. Such right of termination is in addition to and not in lieu of any other remedies, which the District may have in law or equity. Default may be construed as, but not limited to, failure to deliver the proper goods and/or services within the proper amount of time, and/or to properly perform any and all services required to the District's satisfaction and/or to meet all other obligations and requirements. Contracts may be terminated without cause upon thirty (30) days written notice to either party unless otherwise specified. Contracts entered into on the basis of submitted bids are revocable if contrary to law.*

*Federal Work Authorization Program:*

*Prior to commencement of the work, Respondent shall provide to the District a sworn affidavit and other sufficient documentation to affirm its enrollment and participation in the Federal Work Authorization Program. Federal Work Authorization Program means the eVerify program maintained and operated by the United States Department of Homeland Security and the Social Security Administration, or any successor program. Respondent shall also provide the District a sworn affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.*

*Background Checks:*

*Before employment of any employee, contractor, subcontractor, consultant or subcontractors who is an individual for work on the services set forth in the Contract, the respondent shall conduct background checks through all appropriate state agencies and any other background checks as may be standard for entities providing services to public schools, including without limitation, a thorough review of the list of registered sex offenders as provided by the County Sheriff's Department, the Federal Bureau of Investigation's criminal history files, the Missouri Highway Patrol's criminal history database and sexual offender registry, the Family Care Safety Registry, or the central registry of child abuse and neglect of the Missouri Children's Division; and any such individual who does not pass such background check as determined by the District in its sole discretion shall not be permitted to enter the premises where the services are being performed or any other school district property or to work on the services under the Contract. The Respondent shall include all of these requirements in its contracts with their subcontractors and suppliers.*

*Compliance with Anti-Discrimination Against Israel:*

*If applicable, pursuant to Missouri Revised Statute § 34.600, any company, with ten or more employees, awarded a contract for services with a potential value in excess of one hundred thousand dollars (\$100,000) with a Missouri public entity must, as a condition to the award of any such contract, agree not to engage in the boycott of Israeli goods or services either directly or indirectly.*

**FEDERAL WORK AUTHORIZATION PROGRAM ("E-VERIFY") ADDENDUM**

*Pursuant to Missouri Revised Statute § 285.530, all business entities awarded any contract in excess of five thousand dollars (\$5,000) with a Missouri public school district must, as a condition to the award of any such contract, be enrolled and participate in a federal work authorization program with respect to the employees working in connection with the contracted services being provided, or to be provided, to the District (to the extent allowed by E-Verify). In addition, the business entity must affirm the same through sworn affidavit and provision of documentation. In addition, the business entity must sign an affidavit that it does not knowingly employ any person who is an unauthorized alien in connection with the services being provided, or to be provided, to the District.*

*Accordingly, your company:*

4. *Affirms you will notify the District if you cease participation in E-Verify, or if there is any action, claim or complaint made against you alleging any violation of Missouri Revised Statute § 285.530, or any regulations issued thereto;*
