Comparing the financial report to the budget can be difficult for several reasons:

#### Timing of Revenues and Expenditures:

Revenue for schools often doesn't come in evenly throughout the year.

#### Seasonal Spending Patterns:

School districts tend to have seasonal spending fluctuations. Large expenses, such as purchasing supplies or equipment, might occur at the beginning of the school year, while other costs like professional development or summer maintenance may happen later.

**Restricted vs. General Funds**: The financial report might show variances in specific funds compared to the budget, but these variances may not reflect the overall financial health of the district.

#### One-Time Revenues or Expenses:

Schools may receive one-time payments, such as grants or bond revenues, and may also incur one-time expenses like building repairs or special projects **Encumbrances and Accruals**:

In some cases, funds are "encumbered" or set aside for future obligations, such as contracts or purchase orders, even though the actual payment hasn't yet been made.

#### d. Annual Secretary of the Board Report (ASBR)

We have received our ASBR from the state.

What is the ASBR? The Missouri Schools Annual Secretary of the Board Report (ASBR) is a comprehensive financial report that Missouri school districts submit annually to the Department of Elementary and Secondary Education (DESE). It includes detailed information on the district's revenues, expenditures, fund balances, and financial activities for the fiscal year. The ASBR provides transparency in school financial operations, helps with state and federal reporting requirements, and supports the financial accountability and oversight of public school districts in Missouri.

A copy of the ASBR is in the board packet.

Recommendation: Approve the ASBR as presented.

The dates are set by the state, but local boards of education must approve the filing dates as a formality. The superintendent's office is the official location for board candidates to sign up. The public notice, which is required by law to be

published in the newspaper, will reflect the dates and times mentioned above. The Public Notice will state:

The Mountain View-Birch Tree R-III School District will accept declarations of candidacy from any person interested in running for a position on the school board in the April 8, 2025, General Municipal Election. Persons interested may file at the superintendent's office located at 502 N. Elm St., Mountain View, Missouri, 65548

Filing will begin on December 10, 2024 at 8:00 a.m. and will continue during the district's regular business hours which are Tuesday through Friday from 8:00 a.m. to 3:00 p.m. Filing will not occur on days that the school district's offices are closed due to inclement weather. Filing will not occur on the following days when the school district's offices are closed for holidays: December 23-30, 2024. The district office will be open from 3:00 p.m. to 5:00 p.m. on the last date to file, which will be December 31, 2024.

There are two positions available with three-year terms. Candidates will be listed on the ballot in the order in which they file. Each candidate will fill out a Declaration of Candidacy form and receive a copy of the Summary of Missouri Ethics Laws For Candidates For Election to Office In Missouri, provided by the Missouri Ethics Commission.

#### **EXPLANATION**

MSBA has moved language from GBEBB that is more appropriate for this policy code.

Because an effective educational program requires quality staff members, the board and the administration of the Mountain View-Birch Tree R-III School District will make every effort possible to attract and retain qualified, highly skilled and experienced personnel.

The district's hiring procedures will comply with all federal and state laws, including laws prohibiting discrimination. The district is an equal opportunity employer and hires only citizens of the United States and persons who are legally authorized to work in the United States. The Mountain View-Birch Tree R-III School District will enroll and actively participate in a federal work authorization program in accordance with law.

A majority of the board must vote affirmatively to employ any person or enter into an employment contract.

#### **Recruiting and Advertising**

The district will recruit the best-qualified candidates for open positions. New or vacant positions will be posted for at least five business days in the district's buildings and publicized externally by other means as determined appropriate by the superintendent or designee. However, if the superintendent or designee determines that it would be detrimental to wait five business days or that a longer period is necessary, the position will be advertised for the number of days deemed appropriate. Further, if the same or similar position was recently advertised, the superintendent or designee may utilize applications previously received without re-advertising the vacancy. A position is not considered vacant if the superintendent or designee transfers or reassigns an existing employee to the position. Board approval is required when a transfer or reassignment results in a change to the employee's compensation, benefits or contract.

Recruitment procedures will not overlook the talents and potential of individuals already employed by the school district. Any current, qualified employee meeting the stated requirements may apply for new or vacant positions in the district.

All requests for information concerning professional staff vacancies in the district shall be directed to the superintendent or designee.

#### **Screening Process**

Applicants must complete a formal application and provide all required information. The superintendent or designee shall conduct interviews, review references and obtain other information as deemed necessary.

The superintendent or designee will conduct background checks on employees and applicants for employment in accordance with law and board policy and will check references in accordance with law and policy GBLB.

As required by law, before offering employment to any teacher who is or was employed by a Missouri school district or charter school, the superintendent or designee will contact the Department of Elementary and Secondary Education to determine the school districts or charter schools that previously employed the applicant.
