

Returning Students K-12

- The parent/guardian must complete the online enrollment process for their student. It is highly recommended that only one person works on enrolling the student or students. Again, if you cannot remember your login information, please see the above to recover it or email dunsell@coalgateschools.org
- If documents are missing, the Registrar will contact the student parent/guardian via the email address provided by parent/guardian
- The online enrollment may be completed online from a computer, laptop, Chromebook, or a mobile device. However, a larger screen will make the process much easier. The key to a smooth enrollment process is to have all documents uploaded to your device prior to submitting the enrollment
- Incomplete enrollments will not be posted, and your student(s) will not be enrolled in Coalgate Schools. The parent/guardian will be notified when there is a problem with the enrollment AND when the enrollment process is completed and posted.
- If the student was enrolled using the online enrollment last year, many of this year's documents will be populated with the information entered last year. Please review this information to check for accuracy and/or make corrections.
- If the student did attend Coalgate Schools last year but was not enrolled using the online enrollment, please fill out all required and/or applicable documents.

New Student Enrollment

To enroll at Coalgate Public Schools, a parent or guardian shall provide the following:

- If the parent is not the legal guardian we need proof of legal guardianship.
- Proof of residency (utility bill or lease agreement)
- Birth certificate
- Social Security Number
- One of the following:
 - Current, up-to-date Immunization Records; **or**
 - A completed and signed exemption form
- CDIB/Tribal membership card (if applicable)
- any school records (transcript, IEP, etc) from the student's previous school

Please bring the required documents to the appropriate building office.
