### Presentation – Alisa Barrett

Alisa Barrett, Director of Instruction, shared preliminary state testing results in English language arts and math comparing the district against state averages. The results were grouped by graduating classes showing areas where the district increased/decreased and the state increased/decreased. The focus will be in areas in which the district decreased and the state average increased. Overall the district is showing improvement in state testing scores.

House Bill 445 – requires school board to adopt policy allowing student to attend religious instruction  
House Bill 408 – requires school to provide meals and related services  
House Bill 407 – accountability for private schools that accept EdChoice vouchers  
Senate Bill 181 – regarding ticket prices for school-affiliated events  
House Bill 230 – requires school districts to educate student on the dangers of fentanyl  
House Bill 629 – regarding capital funding as related to the biennial budget bill
