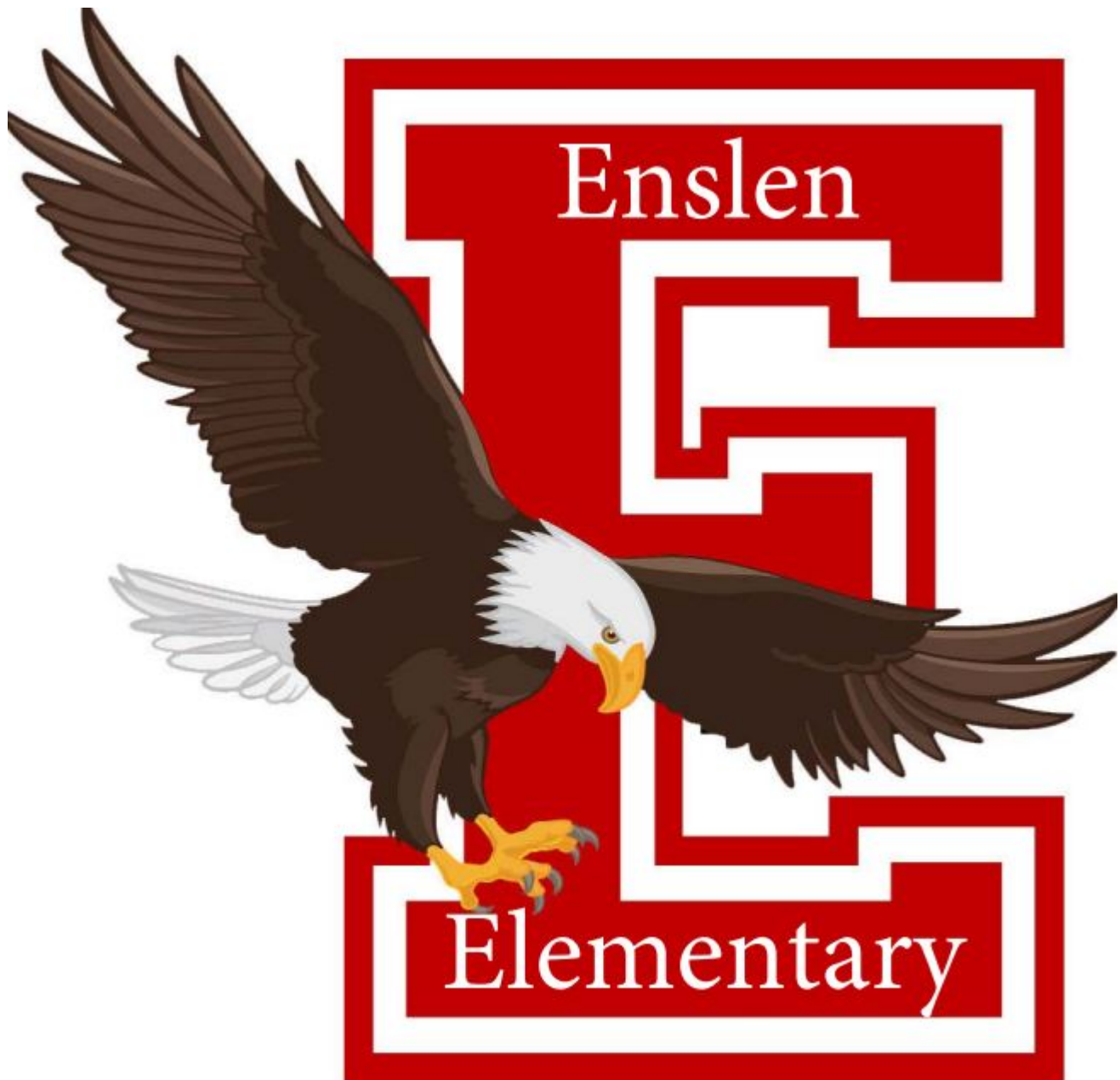

## 2023-24 School Description and Mission Statement

Enslen School was built in 1929 and is proud of its distinction of being one of the oldest operating schools in our district. It is located on a shady, tree-lined campus in an established neighborhood near the center of Modesto and a few blocks from Modesto Junior College. The staff, parents, students, and community have a long-standing sense of "family" and pride for their school. Many after school events are held for the families and community to come together on campus. Enslen has focused on developing and implementing educational programs that are responsive to the needs of students in an ever-changing world. Teachers, parents and support staff collaborate to provide an enriching and supportive environment for all students. Weekly collaboration meetings focus on the PLC process and equity for all students. The small school atmosphere lends itself well to fostering a rich, challenging learning climate and providing opportunities for children to develop academically, socially, and physically.

Enslen has earned the reputation of maintaining high academic expectations and providing a strong educational program. Many of our parents and some grandparents are former Enslen students, and they have deliberately located their families in the Enslen area so that their descendants could continue the tradition of being Enslen graduates. Parents are actively involved and serve in leadership capacities through the Parent Teacher Club (PTC) and other committees. Parent volunteers are historically very involved, providing support and assistance throughout the school. Our educational environment and teaching strategies meet the goals and objectives of a strong curriculum. The Enslen faculty utilizes every opportunity for grade level collaboration centered on analyzing student assessment data and utilizing effective instructional strategies to meet the needs of our students through the PLC process. The Enslen staff is extremely collaborative and is focused on student achievement.

Although Enslen is a small school with somewhat limited resources, the emphasis has been on utilizing funds to provide programs, services, and technology that maximize student performance. Enslen has started a MTSS reading program that is highly successful and meeting the unique needs of each student based on data analysis and small group instruction. Enslen's warm and friendly atmosphere, positive learning environment, and tradition of excellence are the products of partnerships between staff, students, and the community.

### School Facility Conditions -- General Information

The district takes great efforts to ensure that all schools are clean, safe, and functional. ### Age of School/Buildings:

This school has classrooms, a cafeteria, a library, and an administration office. The main campus was built in 1939 and opened in 1939.

### Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service. Emergency repairs are given the highest priority. The school facility is in overall good repair.

### Cleaning Process and Schedule:

The Operations Department has adopted cleaning standards for all schools in the district. A summary of these standards are available at the school office, or at the Maintenance & Operations office. The Maintenance & Operations Department works continuously with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

### Deferred Maintenance:

The District participated in the State School Deferred Maintenance Program, which provided flexible state matching funds to assist school districts with expenditures for major repair or replacement of existing school facilities components. State contributions to this Program ended in the 2012-13 school year. Deferred Maintenance typically includes paving, roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting and floor systems. Carry-over funds for deferred maintenance projects throughout the District in Funds 01 and 14 have been exhausted. The Board has authorized the General Fund (Fund 01) to annually contribute \$2 million to Facility Maintenance (Fund 14) to be used for new construction and maintenance projects throughout the District, \$2 million to Routine Restricted Maintenance (Fund 14) for maintenance projects throughout the District and \$2 million to Facility Improvements (Fund 40) for the District's high schools. Identified needed repairs are weighed against all other District site repairs and the most urgent repairs are addressed first.

## 2023-24 School Safety Plan

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are included within this report. The results of this survey are available at the district office and on the internet at [mcs4kids.com](http://mcs4kids.com).

Student safety is discussed regularly at Staff Meetings, Parent Teacher Club meetings, PBIS team meetings, Yard Duty team meetings and Safety Committee meetings. The School Safety Plan is reviewed by the School Safety Team annually and was last updated and discussed on October 13, 2022 and approved by the Site Safety Team. The Comprehensive School Safety Plan include procedures for emergencies such as a lockdown, fire-drill, evacuation, and more. Contact information has been updated for emergency situations and the procedures are reviewed with staff and student drills are executed to ensure the entire Enslin community knows their role in an emergency situation. The principal meets with students for input on the safety of campus as well as student council for feedback. All staff has been briefed on the procedures and a small red flipchart has been created and distributed to provide a quick resource in the case of an emergency. The safety plan was reviewed with staff on August 3, 2023 and reviewed in following meetings and follow-up emails. The Enslin Site Leadership Team also met and discussed safety procedures on September 25, 2023 and student council provided feedback on September 14, 2023. The site safety plan will be reviewed and updated with the site safety team on November 20, 2023.

The school custodian checks the school grounds for safety each morning before the children arrive. Repairs are made quickly whenever safety issues are involved. Yard duty staff supervises the playground before school, after school, and during recess and support is provided by the principal and teachers when practical. The gates are locked after school begins so that all visitors must come through the front door. A sign is posted at the door informing visitors to report to the office. Visitors sign in at the office and must have their driver's license scanned using the Raptor system. All visitors must wear a Raptor badge while on campus. Before and after-school care programs were initiated in the 2021-2022 school year, to ensure students had a safe, welcoming option when parents needed supervision outside of the school day.

## Professional Development

Professional development in MCS is data driven using research-based best practices to ensure our students receive a guaranteed and viable curriculum in every grade, in every school. We use formative and summative data to drive our instructional decisions and focus for professional development. To this end, we utilize multiple structures to provide high-quality professional development to our staff including: summer training, preservice-days, district wide professional development days, after school workshops, Saturday workshops, substitute-release days, instructional coaching, Induction and intern mentor

programs, Peer Assistance Review (PAR) program, as well as an Administrative Induction Program. For the fourth year, MCS has provided the opportunity for 1% compensation for certificated and management who choose to complete an extra twelve hours of professional development outside of their normal work day. We offer the same incentive for classified, but at a flat rate compensation of \$400 for the first 6 hours and \$400 for the second 6 hours of voluntary professional development hours.

MCS has prioritized our focus on mathematics, literacy across grades and content areas, collaboration, welcoming schools/customer service, English Learners, and building our capacity as professionals. This has been in addition to the needed training in new adoptions, curriculum and standard updates and the like. The professional development is sustained through site administration, district and site level instructional coaches, and intervention specialists. The Curriculum and Instruction & Professional Development Division is tasked with increasing the quality and quantity of professional development provided to classified, certificated, and managers alike.

Coming out of the COVID closures, we have focused our efforts on our Instructional Core:

- Instructional Core Vision: Every student deserves a guaranteed instructional program, not by chance, but by design, including Board-adopted curriculum, researched-based best practices, and authentic relationships and assessments that guide instruction.
- Supporting All Learners: Intentionally planning lessons with consideration for strategies, scaffolds, and interventions that create equitable learning opportunities for all students.
- Board-adopted Curriculum: Intentionally utilizing the currently adopted curriculum to ensure equitable access for all students to rigorous content standards. Understanding how the curriculum design supports students’ progression over time.
- Engaging Students using Language and Literacy: Designing lessons that engage and support all learners by providing daily opportunities to interact with content through reading, writing, listening, and speaking.
- Professional Learning Communities: PLCs are the vehicle we use to guarantee the success of the Instructional Core. Fully engaging in the process of identifying what students need to learn, how it is to be taught, what to do if they don’t reach mastery, and what to do if they excel, with regular review of student formative data to guide instruction.
