Mill Levy: Mr. Turrell presented the mill levy information for the upcoming year. Mrs. Pugh moved, Mrs. Harris seconded to approve the mill levy of 25.909. General Fund mills, 0.006 abatement mills and 3.250 MLO mills for a total Mill Levy of 29.165 on total assessed valuation of $\$ 73,941,805$. They also authorized the administration to modify these figures to meet state requirements if the assessed valuation changes prior to December $10^{\text {th }}$.
