Superintendent Berry presented the levy proposal:

The proposal calls for a 6.48% increase in the PTELL levy and a 5.64% increase overall, including the bond levy and revenue recapture.

The estimated EAV is 153,419,174 (+9.9%) including 2,126,710 (+20.6%) in first time property.

The estimated total tax rate will be 4.93 or 4.09 without bonds and revenue recapture; projected bond tax rate of .83 and revenue recapture rate of .01.

Last year's actual total tax rate was 5.13, including a bond rate of .90 and revenue recapture of .01. The projected bond tax rate for the current year was .89 at the time of last year's levy hearing.

Recommended: Adoption of a levy of \$6,278,470, plus bond levy of \$1,276,628 and revenue recapture amount of \$18,127 for a total levy of \$7,573,225.
