The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The process used to involve parents, teachers, and school staff in the development of our plan was to send out a hard copy and electronic survey explaining the funding, the amounts, and example ideas for expenditure. Stakeholders were asked to provide their suggestions for the District to consider. Data was collected and organized into related categories and then reviewed by administration. The District then used the feedback from our school community to identify the supplemental instruction and support strategies to be implemented: 1) Extending Instructional learning time, 2) Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports, 3) Additional academic services for students. A draft plan was developed and posted on the website for review and for any possible clarifications or additional input.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified and the needs of students will be assessed using State Assessment data (CAASPP), local benchmarks, Dynamic Indicators of Basic Early Literacy Skills (DIBELS), School Climate survey, California Healthy Kids survey, Positive Behavior Intervention and Supports (PBIS), and teacher recommendation. In addition to these tools used on a regular on-going basis for identifying and assessing needs, students are also identified based on attendance and engagement.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and guardians of students will be informed of the opportunities for supplemental instruction and support through our established communication methods of parent bulletin, phone app, website, and classroom teacher communication. For summer school programming,

parents and guardians are directed to an administrative contact for information and enrollment. For information about additional supports and opportunities during the regular 2021-2022 school year, program coordinators may also reach out to families through mailed correspondence and or personal phone calls to invite student participation based on assessment data.

A description of the LEA’s plan to provide supplemental instruction and support.

The District will provide supplemental instruction and support to identified students through implementation of a summer school session (June through August 2021) open to all students as universal support for academic engagement, enrichment, and cooperative physical activities. During the regular 2021-2022 school year, supplemental support is provided to some students after school from the following groups when identified by data as needing more academic, behavioral and social-emotional support: low-income, foster youth, homeless, students with disabilities, disengaged, and below grade level. During the regular 2021-2022 school year, intensified support will also be provided after school to a few students identified by data as needing this higher level of support and may be members of the following groups; low-income, foster youth, homeless, disengaged, and below grade level. To provide expanded learning opportunities in addition to the summer school session 2021, the District will hire 2 additional teaching staff and 4 additional paraprofessional staff for the 2021-2022 school year, and provide staff training using the ELO Grand funds.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

ELO Grant funds are being coordinated with other federal Elementary School and Secondary Emergency Relief Funds to support all students in reducing learning loss, providing a safe school environment, and meeting the needs of identified students who require additional academic and social-emotional supports. In coordination with the ELO funds, other relief funding is targeted at the following: Second Step curriculum and coordinator, Safe School Ambassador, Technology tools/ applications/ licenses, school wide assemblies to enhance student connection and well-being, HVAC repairs and upgrades, a fully functional Public Address system to ensure safety of staff and students while on campus, personal protective gear, cleaning and disinfection products, and counter top and table top barriers.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education (COE), or charter schools, collectively referred to as LEAs, that receive Expanded Learning Opportunities (ELO) Grant funds under California Education Code (EC) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]). The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
