Description of Unpaid/Unfinished Bonds Previously Approved by Voters of the Jurisdiction:

As of the 14th day of October, 2025, Independent School District No. 74, McCurtain County, Oklahoma, has 3 General Obligation bond issue(s) outstanding:

\$2,400,000 Building Bonds of 2017, dated July 1, 2017 (\$570,000 outstanding in principal as of the 14th day of October, 2025);
\$940,000 Building Bonds of 2023, dated January 1, 2023 (\$725,000 outstanding in principal as of the 14th day of October, 2025); and
\$1,300,000 Building Bonds of 2024, dated March 1, 2024 (\$1,300,000 outstanding in principal as of the 14th day of October, 2025).

The School District has \$6,565,000 in unissued building bonds authorized at an election held on the 12th day of October, 2021. These bonds will be used to complete the constructing, equipping and/or acquiring of the multi-purpose vocational agricultural/carpentry classroom building and the improvements at the Middle School.
