#### DESIGNATION OF VALEDICTORIAN AND SALUTATORIAN

The valedictorian and salutatorian titles are determined after the final recording of the third marking period grades of the senior year to acknowledge exceptional academic achievement. Here are the procedures for selecting valedictorians and salutatorians:

- The valedictorian is the student with the highest weighted average after I5marking periods of high school work.
- The salutatorian is the student with the second highest weighted average after 15 marking periods of high school work.
- If there is a tie, calculations are extended to five decimal places for valedictorian selection, and if the tie persists, co-valedictorians are chosen. The same process applies for salutatorians.
- Foreign exchange students are not included in class rank calculations and are not eligible for valedictorian or salutatorian titles.
- Eligibility for valedictorian or salutatorian status requires enrollment before and continuously after the IOth school day of the student's senior year, as a
  full-time student.

### CELL PHONE CODE OF CONDUCT 25'-26' SCHOOL YEAR

I acknowledge that there is, by New York State Law, a ban on student use of personal electronic devices during the school day. This is a "bell-to-bell" ban, from 8:00 a.m. until 2:45 p.m. students can not employ the use of: cell phones, use headphones (unless for a class environment and synced to a Groton CSD Chromebook laptop), "earbuds" or "earpods", personal tablets, Ipod or other MP3 players, handheld gaming devices, smart watches or wrist worn objects, any electronic device that connects to the internet that has not been issued by the school. Any offenses beyond those listed in the code of conduct will result in further disciplinary action for insubordination up to, and including, being placed in ISC for multiple days or Out of School Suspension. Students are required to secure their phones in a school-issued, signal-blocking, lockable bag before the school day starts. At the conclusion of the day, these bags will be unlocked, allowing students to retrieve their phones. **Students must keep these locking bags until the following school day. Please note:** if a phone bag is lost, stolen, or damaged due to negligence, vandalism, or improper handling, the parent or guardian will be responsible for covering the replacement cost of the signal-blocking, lockable bag.
