## **Business Transacted:**

Mr. Tucker moved, seconded by Mr. Bradford, to approve the agenda per Board Policy 1.403, with the following changes:

The motion carried by unanimous voice vote.

There were no recognitions – there will be a banquet following the meeting recognizing the Supervisor, Principal, Teachers and Support Staff Members of the Year.

Student Board Representatives Drew Daniel and Sara Welch reported the following activities from Lincoln County High School:

Mr. Posey moved, seconded by Ms. Tallman, to approve the consent agenda as presented which included:

The motion carried by unanimous voice vote.

There were no policy revisions brought before the Board.

Dr. Daniel moved to not accept the Michigan Model as our new curriculum for family life education and that we stay with the same model we have now, the Tennessee Model. Mr. Stevenson called for a second. The motion failed for lack of second.

Dr. Heath discussed the budget process, reviewing last year's process, emphasizing that the Board does not have the authority to raise taxes, and sharing what the process will look like for the upcoming school year. The first budget meeting will take place on Thursday, April 4, 2024 at 5:00 p.m. If Board members have any budget requests, they should be presented at that meeting. There will be at least one additional budget meeting to finalize the recommendations.

Mr. Tucker moved, seconded by Mr. Bradford, to approve the 141 General Purpose School Fund Budget Amendments as presented. The motion carried by unanimous voice vote.

Mr. Posey moved, seconded by Mrs. Haynes, to approve the 142 School Federal Programs Fund Budget Amendments as presented. The motion carried by unanimous voice vote.

Mr. Bradford moved, seconded by Ms. Tallman, to approve the 143 Centralized Cafeteria Fund Budget Amendments as presented. The motion carried by unanimous voice vote.

Mr. Tucker moved, seconded by Ms. Tallman, to accept the bid by English Service for Chain Link Fence and Gate. The roll call vote resulted in 8 ayes, o nays, o absent.

Mr. Bradford moved, seconded by Mr. Dunn, to accept the bid from Kendall Stage Curtains for Stage Curtains for LCHS. The roll call vote resulted in 8 ayes, o nays, o absent.

Mr. Tucker moved, seconded by Ms. Tallman, to accept the Financial Statements for Funds 141 General Purpose School Fund, 143 Centralized Cafeteria Fund, 146 Extended School Program and 177 Education Capital Projects Fund as of March 26, 2024. The motion carried by unanimous voice vote.

- 1. Board member Cole Bradford read the required Conflict of Interest Statement. "I, Cole Bradford, acknowledge that I have a potential direct conflict of interest as my wife is employed by Lincoln County Department of Education."
- 2. Board members will receive a form to choose their preference on the dates for additional budget meetings. The week of April 22 will be the time frame for the second meeting.
- 3. The list of Tenured Teachers Recommended for Rehire will be added to the Shared Drive.
- 4. Exit Surveys will be completed by students during the last month of school.
- 5. Dr. Heath reported that the annual TSBA dues have been paid for the 2024-2025 school year.
- 6. Dr. Heath reported Facility Use Requests approved by Executive Committee Rabies Clinics at HRS, South Lincoln and Blanche.
- 7. A letter from County mayor Bill Newman congratulating the system on its outstanding rankings was read to the Board.
- 8. Dr. Heath discussed the process for Board approval for curriculum, specifically addressing proposed lessons for the Family Life Curriculum. He noted that Board policy and state law would be adhered to. Dr. Daniel made a point of order concerning the discussion on the Family Life Curriculum. Mr. Stevenson addressed the concern, noting that the Director was updating the Board on the process, not discussing the actual agenda item.

Mr. Tucker moved, seconded by Ms. Tallman, to adjourn. The motion carried by unanimous voice vote.
