The Randolph Eastern School Corporation Board of Trustees met at 5:00 p.m. on February 15, 2024 for a regular Board meeting.

- \$100,000.00 from Indiana Family and Social Services to establish an Employer Sponsored Child Care. RESC is expected to match this grant with a \$10,000.00 contribution to the Daycare.**
- \$5,000.00 from the Eastern Central Service Center. These funds are from the HB 1008 Learning Recovery Grant and are used to cover the cost of travel to visit Innovative Schools.**
- \$10,000.00 Project Lead the Way Grant for North Side**
- \$15,000.00 Project Lead the Way Grant for Union City Jr/Sr High School**
