Andrea Miller was in 6th grade when her class adopted a Marine Unit to be pen pals with when the Marine she was writing was killed in action. Andrea vowed to be there for this Marines' family and each year raised money to make sure his family had a Christmas. Andrea has been a supporter of our troops and veterans, and for all she has done we honor her in creating this in house scholarship to give out to other students who go above and beyond.

The scholarship is offered once each year and will be awarded to one student from one of the following schools; Mason County Central, Bear Lake, Brethren/ Kaleva Norman Dickson, Manistee Public, Frankfort High School, or Benzie County. The recipient of this scholarship must be a student in good standing and plans on attending a program at a 2 year college, 4 year university, or trade school. This award will be paid to the school in which the student has been accepted. This scholarship will only be available one time per student.

The Criteria for the Andrea Miller Tri-County Scholarship

It would be Rolling Thunders desire that the scholarship recipients have a genuine need for financial assistance.

- The scholarship will be offered to students whose grade point average is 2.0 or above and who
 qualify for financial aid.
- 2. Applicants will submit a letter with their application to the Guidance Counselors Office to why they believe they would be a good candidate for this scholarship. The letter must also include three references, contain reasons why the applicant feels consideration for the scholarship is warranted and be written in the students own words. The letter will be significant factor in awarding the scholarships attention to content and presentation will be very important. Application and letter must be turned into the Guidance Counselors Office no later than May 17th 2024.
- 3. Applicants must have been accepted by a university, college, or trade school.
- 4. Applicants must be from a Veterans background or must be volunteering for a veteran's organization or volunteering within their community.
- 5. Applicants must be respected by their peers.
- 6. Finally, Rolling Thunder would enjoy regular reports from the recipients about their progress and growth as a student and person.
