SCHOOL, PARENT AND FAMILY ENGAGEMENT POLICY

Junction Hill is a schoolwide title program.

The policy for school parent and family engagement has been collaboratively developed with the participation of parents of participating children, including those of migrant and EL children. This policy is then distributed to parents and agreed upon by them, as per Section 1116 (b)(1).

Junction Hill conducts annual spring and fall meetings, during which parents are informed and invited to participate in the development of plans, offer suggestions, or propose changes. Surveys are also used to provide families with the opportunity to give input. Furthermore, a working meeting is held to which parents are invited to contribute to the development of plans and to consider changes suggested through surveys and family needs.

To ensure that the policy is easily comprehensible, parents are notified of it in a uniform and understandable format, as specified in Section 1116(b)(1). Additionally, the school parent and family engagement policy is provided to parents in a language that they can understand.

POLICY INVOLVEMENT

At the start of each school year, the school holds an annual meeting that is convenient for all parents of participating children to attend. All parents are invited and encouraged to participate in this meeting, as per Section 1116(c)(1).

The purpose of this meeting is to inform parents about the school's participation in the Title I.A program, explain the requirements of Title I.A, and outline parents' rights to be involved. This is reflected in the meeting agenda, as per Section 1116(c)(1).

To ensure flexibility, the school offers a flexible number of meetings for parents to attend, as per Section 1116(c)(2).

The school also involves parents in an organized, ongoing, and timely way, specifically in the planning, review, and improvement of the Title I.A program and the school parent and family engagement policy, as per Section 1116(c)(3).

Furthermore, the school provides timely information about the Title I.A programs to parents of participating children, as per Section 1116(c)(4)(A). Additionally, parents are provided with a detailed description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure progress, and the achievement levels of the MAP assessment.

Junction Hill conducts annual spring and fall meetings, during which parents are informed and invited to participate in the development of plans, offer suggestions, or propose changes. Surveys are used to provide families with the opportunity to give input. Furthermore, a working meeting is held to which parents are invited to contribute to the development of plans and to consider changes suggested through surveys and family needs.

During Open House, teachers share information about the curriculum and assessments used at the school. At each of the two parent-teacher conferences, MAP achievement, academic assessment results, and student performance are shared and discussed with parents. The overall school MAP achievement is shared at the annual meeting.

The school provides opportunities, as appropriate, for parents to participate in decisions relating to the education of their children, as per Section 1116(c)(4)(C). Additionally, the school responds to parents' suggestions as soon as possible, as per Section 1116(c)(4)(C).

SHARED RESPONSIBILITY FOR HIGH STUDENT ACHIEVEMENT

School-Parent Compact

BUILDING CAPACITY FOR INVOLVEMENT

Junction Hill provides materials and training to assist parents in working with their children to improve achievement. As per Section 1116 (e)(2), teachers will supply families with necessary materials to supplement classroom learning. Additionally, teachers will offer strategies and guidance to parents on how to support their students. An activity night is also scheduled for parents and their children to participate in. This activity night will be a literacy night in the fall.

Junction Hill places great emphasis on fostering positive relationships between school personnel and parents. As such, we prioritize ongoing professional development to educate teachers, specialized instructional support personnel, principals, and other school leaders on the value and importance of parent contributions. We work collaboratively with parents to develop and coordinate parent programs such as the Parent Teacher Organization and Booster Club, and actively seek to build strong ties between parents and the school. Section 1116 (e)(3) serves as a guiding principle for our approach to parent-school partnerships.

In order to promote meaningful parental involvement and foster collaboration between the school, parents, and community to enhance students' academic performance, the school shall endeavor, wherever possible and suitable, to harmonize and incorporate parent involvement initiatives and events with other Federal, State, and local programs, including public preschool programs. The school shall also conduct additional measures such as parent resource centers to inspire and assist parents to become more engaged in their children's education. This is pursuant to Section 1116 (e)(4).

Junction Hill provides multiple opportunities to encourage parents to participate more fully in their children's education. These include a volunteer program, a highly active Parents Teacher Organization, and planning meetings that parents are welcome to attend throughout the year. Additionally, Open House nights, parent-teacher conferences, and activity nights are held and announced to parents through letters, flyers, outreach phone calls, the website, and the school's Facebook page.

The school is responsible for ensuring that all communication pertaining to school and parent programs, meetings, and events is conveyed to the parents of participating children in a clear and understandable format and language. This is in accordance with Section 1116 (e)(5).
