From the Superintendent's Desk

Attendance, Communication, Conferences...OH MY.

Due to the increasing costs of postage and time required to put together and mail the monthly Coyote Connection Newsletter, we have decided to move to a digital copy that will be loaded and stored on the school website starting in October. For those who do not have internet access or prefer a hard copy of the newsletter, please contact the school at 402.482.5233 to be placed on the mailing list.

Study after study has shown how important regular school attendance is for academic success and graduation. Good attendance and punctuality at school is a great life lesson that will have a long-term impact on one's future endeavors after graduation. However, there are conditions requiring a student to be sent home or to stay home. If he/she has a temperature greater than 100 degrees, vomiting, diarrhea, unexplained rashes, live head lice, or as determined by the school nurse that the child's condition prevents meaningful participation in the educational program, presents a health risk to the child or others, or that medical consultation is warranted unless the condition resolves, a child must stay and/or be sent home. Students must be symptom and fever free without the use of fever-reducing medication for 24 hours prior to returning to school.

If your child must be absent from school for any reason, please contact the school at 402.482.5233 to report their absence. A call prior to 9:00 AM would be the most beneficial.

Occasionally, a student will need to be excused early from school. Students will not be dismissed or

released from school until confirmation from a parent has been received. Parents will need to notify the school before the student is released.

The district encourages communication with our parents and patrons. However, there are some considerations that should be accounted for in the communication process. First, not all faculty will distribute their personal contact information. Every staff member has a school email address where they can be contacted. Every staff member also has access to phone services in their rooms and has the ability to take voice messages. If you contact a staff member by either email or phone, you should expect a response within 24 hours. Some

staff may share their personal contact information with you but please be cognizant of the time you are contacting them. Texts and calls during the school day will most likely go unanswered as teachers will be busy. They may have the opportunity to check their phones during a plan period or during lunch, but their days are hectic and full; it is quite possible they may not see your call or text until after 3:30 PM. Faculty should address how they prefer to be contacted during parent-teacher conferences. Please share with the teachers how you, as a parent, prefer to be contacted as well. That could be by text message, email, or phone call depending on the situation. Parent-teacher conferences are scheduled for Wednesday, September 24 from 3:00 PM to 8:00 PM. Students will be dismissed from school at 1:00 PM on this day. Please note that parent-teacher conferences have changed to Wednesday, September 24 due to conflicts with the activity schedule.

If you have questions about a specific topic, please contact the school directly at 402.482.5233. At that point and time your call will be directed to the individual who can best answer your question or address your concern.

Counselor's Corner

Fall MAP and NSCAS testing will be the week of September 8, 2025. For students to perform their very best on the assessments, it's important that they are well-rested and have breakfast or a snack before the testing session.

Seniors should be scheduling college visits and/or job shadow experiences during the fall. September and October are the recommended months for applying for college. Many colleges offer free applications during the fall months. I am always available to assist students during this process. I highly encourage seniors and senior parents to visit EducationQuest for an abundance of college and career planning resources. The web address is www.educationquest.org. EducationQuest offers financial aid seminars and FAFSA completion assistance.

Last year Governor Pillen signed LB705 into law. One of the components of this bill is a provision to require all public high school seniors to complete the Free Application for Student Aid (FAFSA) to graduation. Here are key pieces of the information that parents need to know regarding this law:

- The legislation includes the ability for a parent/legal guardian of a school principal to opt a student out of the requirement.
- Students 19 or older or emancipated minors can opt out of the requirement..

The 2026-2027 Free Application for Federal Student Aid (FAFSA) will open selectively on October 1, 2025. It will open for everyone on December 1. Due to a lack of participation, Chambers will NOT be hosting a FAFSA completion day as we have in the past.
