

MINUTES OF SALE OF BONDS

The Board of Education of Independent School District Number 76 of Canadian County, State of Oklahoma, met in Special Session at the Calumet School Conference Room (Room #130), Calumet School Conference Center, Calumet Public Schools, Main and Freehome, Calumet, Oklahoma, in said School District on the 15th day of March, 2024, at 1:00 o'clock p.m.

Notice of this special meeting was given in writing to the County Clerk of Canadian County, Oklahoma at 10:51 o'clock a.m. on the 21st day of February, 2024, forty-eight (48) hours or more prior to this meeting, and public notice of this meeting, setting forth the date, time, place and agenda was posted on the north door of the Calumet School Conference Center, Elementary Building, in prominent view and open to the public twenty-four (24) hours each day, seven (7) days each week at 11:00 o'clock a.m. on the 14th day of March, 2024, being twenty-four (24) hours or more prior to this meeting, excluding Saturdays, Sundays, and State designated legal holidays, all in compliance with the Oklahoma Open Meeting Act (as attached hereto).

It appearing that due and legal notice had been given that said School District would offer for sale at the Calumet School Conference Room (Room #130), Calumet School Conference Center, Calumet Public Schools, Main and Freehome, Calumet, Oklahoma, on the 15th day of March, 2024, at 12:30 o'clock p.m., its \$2,630,000 of General Obligation Building Bonds of 2024, maturing \$1,315,000 in two years from their date and \$1,315,000 annually each year thereafter until paid, the Board of Education proceeded to consider the bids received for the purchase of said Bonds. 
