SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Throughout the months of May and June 2021 the district administration met with building leadership, staff, the board of education and the community to discuss the American Rescue Plan funding and guidelines. The district created a plan for spending and presented the plan in public at a board meeting. In addition, a presentation was also made to our Community Superintendent Advisory Council (SAC). This council consist of community members that reflect the diverse background of the community. Dialog was had with the community stakeholders at that meeting about the program proposals and timelines for the funding. The district posted the plan on the website for additional public feedback/review.

The district will meet with stakeholders through PTA, SEPTA, Superintendents Advisory Council, Principal weekly newsletters and Shared Decision Making Committees, which will allow the opportunity to gain insight into every effort that is being made to provide the highest quality instructional program to meet the needs of every child best. We are confident that several of the interventions and exciting new programs that have been introduced district-wide and at the school level will make this school year a successful experience for our students.

The district will be opening schools with the most current CDC and Local DOH guidelines in September. The district will not utilize ARP funds for cleaning supplies and materials or PPE, but in turn will hire additional support staff for mental health support, learning loss support and additional AIS staff in order to provide services to more students in smaller group settings in order to be in compliant with social distancing guidelines/practices.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Malverne School District has been implementing a comprehensive system of support for academics and behavior. This approach to school improvement includes implementing evidence-based instruction and interventions across a continuum to support students' needs, a comprehensive screening and assessment system, and continuous data-based decision-making. To identify and address student learning gaps, we will be combining data from Nationally -Normed Assessments (STAR) in Reading in Math with the adaptive learning software. STAR assessments will be strategically administered three times throughout the year -- beginning of the year, middle of the year, and end of the year. The district is increasing the robustness across all tiers of instruction in literacy K-12. This includes adopting and expanding an evidence-based curriculum in both core and supplemental interventions in literacy to ensure that every student who needs intervention will have access and that the intensity of instruction is excellent enough to accelerate any unfinished learning that resulted from the pandemic. Increasing the robustness in schools requires more staffing to support the number of students needing intervention and outreach to address any barriers that students may be facing that may prevent them from benefitting from increased intervention support.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

At the secondary level, a STEM Academy program will be offered to address academic impact of lost instructional time and provide additional instruction. Funding will also be used to hire additional reading teachers at the elementary level to assist in maintaining class sizes at lower levels and the opportunity for more direct student interaction compared to prior years. The district will also be utilizing a County medical establishment/facility to support students mental health. The District's required reserve of 20% of funds to address the impact of lost instructional time will be utilized to cover these expenditures (Reading teacher salaries, STEM Academy Program at the High School, and Mental Health services for K-12 (Northwell Health)).

The district will be using the remaining funds to employ additional support staff. These positions will remain for the next three years as long as the student needs warrants the staffing need. Administration will continue to monitor all student progress through assessment tools in order to determine the staffing needs for each year. In addition, funding will be used for an intro to reading elementary program, internet connectivity such as WAPs and switches, professional development for teachers and mental health counseling staff, a districtwide software communications platform, and equipment/supplies purchases for buildings and grounds to clean facilities operated by the District and to maintain the operations of and continuity of services within the District.

The district will use funds to implement evidence-based strategies to meet students' social, emotional, mental health, and academic needs through the employment of a social worker and a shift in guidance counselors K-12, implementing programs to reduce student anxiety, curriculum development pertaining to social-emotional learning, securing professional speakers for student engagement and implementing staff development programs centered around improving students' social, emotional, mental health and academic needs.

Using District data, the routinely collected data outlined in the data review will be disaggregated by student population to analyze trends in growth across those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students... The district will cover costs of specific activities, services, supports, programs, and or targeted interventions. The interventions selected are intended to accelerate growth beyond what is typical in a standard school year without intervention. If accelerated growth is not as expected for a given population of students, problem solving at the school and District level will occur and additional supports will be put in place to increase the growth trajectory.
