

Projected Tax Levy Impact

Maximum Allowable Tax Levy increase with 50% + 1 Vote: 2.13% increase


District's initial **Proposed** 2024-2025 Tax Levy increase: **2.00% increase**

Fund Balance & Reserves


The District has continued its commitment to the return of over \$1.2M to the Taxpayers from the budget to reduce taxes and maintain budget expenditures.

Supplemented reserves to assist with Insurance, Debt Service, Teacher Retirement System Contributions, Employees Retirement System Contributions, etc.



Maintained reserve levels to provide cash flow and address large, unexpected changes in expense or revenue projections.

May 2024 Propositions

- 1. <u>Prop #1:</u> 2024-25 Budget/Tax Levy
 - Proposed Budget: \$71,273,893
 - Proposed Tax Levy: \$48,660,032



- 2. Prop #2: Capital Reserve Fund Expenditure
 - Proposed Expenditure: \$1,700,000

Capital Reserve Fund Expenditure (Prop #2)

- These expenditures will be at NO ADDITIONAL COST
- Proposition to authorize the expenditure of \$1,700,000
- The following projects are being proposed:
 - HTH Auditorium and Bathroom Upgrades
 - DAV & MWD Bathroom Upgrades
 - MHS Drop Ceiling Replacements
 - Districtwide Door Upgrades
 - Purchase of Grounds Trucks/Maintenance Vehicles



What happens if the proposed budget is not approved on May 21st?



The district may do one of the following:



- Resubmit the defeated budget to the voters on June 18, 2024
- Submit a revised budget to the voters on June 18, 2024
- Adopt a contingent budget
