A special meeting of the Board of Education of Arcola Community Unit District #306 Arcola, Illinois was called to order in the High School Library at 7:00 p.m. on Monday, February 26, 2024 for the purpose of regular business.

President L. Shonkwiler called the meeting to order. The following members answered roll call: Stout, L. Shonkwiler, Conlin, Leyva-Sanchez, Myers, J. Shonkwiler, and Wise.

President L. Shonkwiler recognized the visitors and asked for public comment. There were no comments.

Business:

Motion by Stout, seconded by Leyva-Sanchez, to approve awarding the bid for the high school locker room renovation to K. Wohltman Construction to include the base bid of \$847,500 and alternate bid #2 of \$8,600 for a total cost of \$856,100. Roll call vote: Stout, aye; L.
