All students in grades k-3 will be assessed three times a year. Students that are identified as at risk for academic failure will be provided with 30 minutes of extra instruction time daily in the title classroom. Students will also be offered after school tutoring twice a week by their classroom teacher.

Description of how strategy/strategies will strengthen

Supplemental programs such as Wonder Works, heggerty, and 95% group Phonics will be used to help strengthen the academic programs used in the classrooms.

Students will be given additional reading time of 30 minutes a day five days a week.
