A Special Meeting of the Board of School Directors of the Hanover Area School District was held on Thursday, July 11, 2024, at 6:00 PM. The meeting was called to order by the Board President, Brian C. McDermott.

PUBLIC COMMENT:

Dakota Zyskowski, Assistant Coach HASD Girls Softball addressed the Board, noting the following:

- Concerned regarding the rule of head coach not allowing “coaches coaching family” which would result in her firing.
- Noted the rule contradicts the team motto of “one team one family” and noted other district sports allow family members of student athletes to coach.
- Noted she “was not given a voice at practices, leading same drills over and over”.
- Lack of communication and respect from the current head coach.
- Noted she was “fired via text message”.
- Thanked Board for the opportunity to speak and hoped for support to allow her to continue coaching.

Cheyenne Zyskowski, Student Athlete HASD Girls Softball, addressed the Board, noting the following:

- Noted the team was promised a different outcome at the start of the season with the motto of “One Team One Family”, yet the season yielded the same culture as previous seasons.

- Concerned for change to occur for the upcoming season, her Senior year.
- Believes it unfair to Coach Zyskowski that she be fired without allowing her a proper and fair chance to succeed.

Amber Zyskowski, parent of Dakota and Cheyenne, addressed the Board, noting the following:

- Felt Dakota never got the “respect she deserved as a coach” and Cheyenne was treated the same way throughout the season.
- Opined that Dakota was regarded more like a player by Coach Ann, rather than a Coach.
- Noted the situation was brought to Mr. McCree and the Superintendent’s attention on numerous occasions (3 occasions) of the way the Head Coach was treating Dakota and Cheyenne.
- Situation became frustrating as a parent, knowing the kind of individuals they are and deserving of so much more.
- Emails to the district have outlined the treatment her daughters received from Coach Ann.
- Genuinely hopes that the Board will investigate the matter, as Dakota genuinely cares for the student athletes under her care. She is capable of so much more than what she is currently allowed.

An unidentified member of the public addressed the Board on behalf of Boys Wrestling. She noted the following:

- Boys in the wrestling program have known Chris Kane since Kindergarten. He has raised these boys into wonderful young men.
- Kane’s dedication to the program goes far beyond the wrestling room.
- He has always been a positive role model to them, giving up much of his own personal time to make the Hanover Boys Wrestling Program better.
- I may not agree with your choice here tonight. I just wish you could have asked the boys what their opinions were and who they thought might be the best choice.
- My son has wrestled for 10 years and would not be half of what he is now if not for Chris and some of the other coaches.
- Understands the decision was made, but believes it was the wrong decision, and may impact future participation of her son and several others.

Father of Derek Morgan addressed the Board on behalf of Boys Wrestling. He noted the following:

- Confused by the agenda, because the wrestling coach was not posted.
- Noted that there were some board members present that supported another choice and asked if that choice was going to be presented.

- Superintendent Barrett responded that no other choice would be presented as the item for the wrestling coach selected by majority vote and it was a final decision.
- Noted that he was very disappointed.

Dwight Smith, father of an incoming freshmen wrestler.

- His son wrestled under Chris Kane for the last 8 years, year-round.
- Understands the board had a difficult decision. Believes both options were good options—noting “that is a good problem to have”. However, he stated he believes “the wrong choice was made”.
- Noted he’s been around wrestling for 8 years and has seen “a lot of crappy programs. Hanover does not have a crappy program”.
- Chris ran the elementary program for 8 years and was the Junior High Coach for the last 2 years. “I don’t think he was given a fair chance.”
- Noted that Chris was not here tonight because he is at a wrestling practice. His life is his wrestling. He doesn’t just care for his son. He cares for every one of the kids in the room.
- “I understand your decision is made. I think it’s the wrong one and I think a lot of people feel the same way and will be disappointed.”]
- “I think perhaps there should have been some discussion with the students who are involved in this for whom you are making these decisions.”

Daniel Erickson, Ashley, addressed the Board and noted the following:

- I was one of the applicants for the Head Coach wrestling position.
- I believe my application and Chris Kane’s were overlooked for this position, mine specifically, because I am very young.
- I understand the decision was made. I am disappointed with the decision. I love these kids; they are like little brothers to me.
- I do not see this decision going well for this school and I believe that there should have been a better deliberation process. I wish you guys good luck with the upcoming wrestling season.


