Acceptable Outerwear Styles

Can be worn inside the school building any solid color or style. EISD letter jackets and school organization sweaters or jackets are acceptable.

Unacceptable Outerwear

- > Trench Coat
- > Duster
- > Robe

Acceptable Socks/Hosiery/Leggings

Socks (ankle, mid-calf and knee), hosiery, leggings and tights. When hosiery, leggings and tights are part of the attire they must be worn under skirts or dresses and must be no more than 3 inches above the knee.

Acceptable Styles of Hair

➤ Hair styles must appear neat and clean. Hair color or style that disrupts the school environment will not be allowed. Combs or picks are not allowed to be worn in the hair

Acceptable Head Coverings

None, except for special occasions approved by the principal. Exemptions and optout provisions will be considered for religious or medical reasons.

Unacceptable Head Coverings

➤ Head covering are not permitted and cannot be visible on campus, in the school building, or in the waiting areas on campus. Head covering include but are not limited to sweatbands, caps, hats, bandanas, skullcaps and hoodies.

Tops and Bottoms

- Any shirt or graphic t-shirt that does not display provocative, offensive, violent, or drug related pictures or slogans as well as those advertising alcoholic beverages or tobacco. All shirts must touch the waistband in the front, back and sides. Logos are restricted to the manufacture embroidered logos.
- ➤ Pants, Jeans, and Shorts can be worn. If they have rips or frays they cannot expose the skin above the knee. Shorts and skirts must be no more than 3 inches above the knee
- ➤ No sagging
- Leggings and yoga pants may only be worn under a skirt or dress that must extend no more than 3 inches above the knee.
- ➤ Length: PK-12: Hem of the skirts and shorts must not be more that 3 inches above the knee.

Unacceptable Styles of Bottoms

- ➤ Shorts or skirts that are not the required length. Leggings or yoga pants without a skirt or dress the required length.
- No pajama pants

Acceptable Footwear

Shoes must be appropriate for outdoor and indoor activities. Examples of acceptable shoes are tennis shoes or closed-toe shoes appropriate for both indoor and outdoor activities

Unacceptable Footwear

- > Crocs
- > Steel-toed boots or shoes
- > Open-toed shoes
- > Flip Flops

Other Items

Unacceptable

Students *MAY NOT* wear anything that disrupts learning, including:

- ➤ Accessories that could pose a risk or danger to others

- ➤ Blankets
- > PK-5- Artificial nails and large hoop earrings
- > NO PAJAMA PANTS

Acceptable Socks/Hosiery/Leggings

Acceptable Head Coverings

Unacceptable Head Coverings

Head coverings are not permitted and cannot be visible on campus, in the school building, or in the waiting areas on campus. Head coverings include, but are not limited to sweatbands, caps, hats, bandanas, skull caps and hoodies.









Tops and Bottoms

- Any shirt that is NOT provocative, offensive, violent, has drug related pictures or slogans, as well as those advertising alcoholic beverages or tobacco
- All shirts must touch the waistband in the front, back, and sides. Logos are restricted to the manufacture embroidered logos.
- ➤ Pants, jeans, and shorts can be worn. If they have rips or frays, they cannot expose skin above the knee. Shorts and skirts must be no more than 3 inches above the knee.
- > No sagging
- Leggings and yoga pants may only be worn under a skirt or dress that must extend no more than 3 inches above the knee.
- Length: Grades PK-12: Hem of the skirts/ shorts must not be more than 3 inches above the knee.

Unacceptable Styles

- ➤ Shorts/skirts that are not the required length
- Leggings or yoga pants without a skirt or dress the required length
- > Crop tops or tank tops
- ➤ Biker shorts

Acceptable Footwear

Shoes must be appropriate for outdoor and indoor activities. Examples of acceptable shoes are tennis shoes or closed-toed shoes appropriate for both indoor and outdoor activities.

Unacceptable Footwear

- > Crocs grades PreK-12th
- > Steel-toed boots or shoes
- ➤ Open-toed shoes
- > Flip Flops



Other Items

Unacceptable:

Clear Backpacks are Required for PreK -12th Grade

Allowable	Not Allowable
May have colored or padded straps and zippers.	May not be a tinted, colored backpack. Only transparent bags are allowable.
May have leather or vinyl edge reinforcements as long as visibility is not obstructed.	May not be a mesh backpack.
May have a non-clear clutch bag (5"x 8" or smaller) inside the backpack/bag for cell phone, money, or hygiene items.	May not have back padding. It must be visible on all sides.
May have a non-clear lunch box or lunch bag (6"x 9" or smaller).	May not be lined with fabric or wallpaper that conceals content.
May have non-clear bags for medically necessary items as prescribed by a medical doctor.	May not have large logos, patterns, or decals that obstruct visibility.

- Backpacks, purses, and totes must allow for a maximum level of content visibility.
- All bags are subject to being searched in alignment with security protocols.
- Bags or cases for extra-curricular activities are not required to be clear but must be stored in their designated location immediately upon arrival at school.
- These guidelines also apply to school buses, field trips, summer school, and Saturday school.
- Students who disregard the clear bag expectations will receive consequences for recurring violations.
- It is at the discretion of the campus administration regarding whether a backpack or bag meets the clear backpack guidelines and allows for a maximum level of content visibility.
