Note: Facilities may be added or removed as needed. The Town of Eagar owns the current propane tanks at each facility.

A tour of the sites may be arranged with the Town Clerk during regular business hours (7 a.m.-5:30 p.m. Monday-Thursday)

BIDDERS:

All bidders must show an Arizona Transaction Privilege Tax license and hold or obtain a Town of Eagar Business License. SERVICE REQUIREMENTS:

- Perform routine tank maintenance as needed.
- Check tank levels weekly from November to March.
- Check tank levels at least every two weeks in October and April.
- Check tanks monthly during the months of May, June, July, August, and September.

OPTIONS:

From time to time the Town may request additional services, or services at another location. Such cases shall be addressed on a case-by-case basis.

ESTIMATES:

For estimating purposes, usage from July 1, 2023, through May 30, 2024, was approximately 10,000 + or - gallons. Seasonal variations and modifications to facilities may cause this figure to fluctuate. The Town does not guarantee a need for 10,000 gallons annually. Need is unlikely to fall below 9,000 gallons per year under any circumstances.
