A. Welcome & Introductions

B. Overview of SHAC Purpose & Goals

Mrs. Gonzalez-Barajas reviewed the **SHAC purpose, goals, bylaws, and membership.**

C. Planning for 2025-2026 Initiatives (Member input on priorities and needs)

Members identified three focus areas: **Bullying Prevention, Food & Nutrition, and Community Engagement.**

1. Bullying Prevention

- SHAC requested additional resources to be researched.
- Approved the creation of an **October social media campaign** to promote the Tarpon Tip Line and anonymous reporting.
- Requested that **law enforcement provide presentations** to students and families addressing bullying and David's Law.

2. Food & Nutrition

- Requested that food items continue to be monitored.
- Agreed to **invite the Food & Nutrition Services (FNS) Director** to the next meeting.
- Suggested creating a **Food Panel for Parents**, where families can ask questions and sample meals offered to students.

3. Community Engagement

- Proposed a **“Lunch Bunch Crew” mentoring program**, inviting select community members to meet and have lunch with students monthly (pending approval).
- Confirmed SHAC-led community drives:
 - **Canned Food Drive** – November 3–20, 2025.
 - **Toys for Tarpons Drive** – December 1–16, 2025.

D. Open Discussion & Announcements

- **SB 12 consents were acknowledged.**
- **School Climate Surveys will be released soon.**

E. Next Steps & Meeting Dates

The TEA 4 mandated meetings were designated for: Tuesday, October 28, 2025, Tuesday, January 27, 2026, Tuesday, March 31, 2026. All meetings are subject to time & location change.

Additional meetings may be scheduled at committee discretion.

Action items assigned:

- Research additional bullying prevention resources.
- Plan October social media campaign on bullying/Tarpon Tip Line.
- Coordinate with law enforcement for bullying/David's Law presentations.
- Invite FNS Director to next SHAC meeting.
- Explore logistics for parent food panel and "Lunch Bunch Crew" program.
