LEGAL DESCRIPTION of Burlington Public School District No. RE-6J (Joint with Kit Carson and Yuma Counties)

Burlington Public School District No. RE-6J consists of all territory within a boundary line described as follows (All Townships (T) are south of the 40° Base Line and all Ranges (R) are west of the 6th Principal Meridian):

- 8. Thence north along the ½ section lines to the N 1/4 corner of Sec. 5, T.10 S, R.44W;
- 9. Thence west to the SW corner of Sec. 32, T.9S, R.44W;
- 10. Thence North to the NW corner of said Sec. 32, T.9S, R.44W;
- 11. Thence east to the N 1/4 corner of said Sec. 32, T.9S, R.44W;
- 12. Thence north along the ½ section lines to the S 1/4 corner of Sec. 32, T.8S, R.44W;
- 13. Thence west to the S 1/4 corner of Sec. 31, T.8S, R.44W;
- 14. Thence north along the ½ section lines to the S 1/4 corner of Sec. 19, T. 6S, R.44W;
- 15. Thence west to the SW corner of said Sec. 19, T.6S, R.44W;
- 16. Thence north to the SW corner of Sec. 7, T.6S, R.44W;
- 17. Thence west to the SW corner of Sec. 12, T.6S, R.45W;
- 18. Thence north to the W 1/4 corner of Sec. 1, T.6S, R.45W;
- 19. Thence west to the W 1/4 corner of Sec. 2, T.6S, R.45W;
- 20. Thence north to the NW corner of said Sec. 2, T.6S, R.45W;
- 21. Thence west to the SW corner of Sec. 34, T.5 1/2S, R.45W;
- 22. Thence north to the point where the W line of said Sec. 34, T.5 1/2S, R.45W would, if extended north, intersect the N boundary line of Kit Carson County:
- 23. Thence west along the boundary line common to Kit Carson and Yuma Counties to the SW corner of Sec. 32, T.5S, R.45W;
- 24. Thence north into Yuma County to the NW corner of said Sec. 32, T.5S, R.45W;
- 25. Thence east to the NE corner of said Sec. 32, T.5S, R.45W;
- 26. Thence north to the NW corner of Sec. 28, T.5S, R.45W;
- 27. Thence east to the NE corner of Sec. 25, T.5S, R.45W;
- 28. Thence south to the SE corner of Sec. 36, T.5S, R.45W, being a point on the N boundary line of Kit Carson County;
- 29. Thence east along said N boundary line of Kit Carson County to the E line of Sec. 31, T.5 1/2S, R.44W, extended N if necessary;
- 30. Thence south to the SE corner of said Sec. 31, T.5 1/2S, R44W;
- 31. Thence east to the SW corner of Sec. 34, T.5 1/2S, R.44W;
- 32. Thence north along the W line of said Sec. 34, T.5 1/2S, R. 44W, intersection with the N boundary line of Kit Carson County.
- 33. Thence east along said N boundary line of Kit Carson County to the point of beginning.
