Redhawk First Steps Scholarship Policies

Scholarship description: The USD 415 Educational Foundation Redhawk First Steps Scholarship was established by the Foundation in 2022 because of educators and parents identifying the need for financial support of students at Hiawatha High School. The scholarships will support students enrolling in Highland Community College dual credit courses. The scholarship may expand in the future for opportunities beyond Highland Community College.

Funding resources: The funding of the scholarship will be from multiple sources and will continue to evolve. Sources include Hiawatha Community Foundation Day of Giving campaigns, private donations, general use donations to the Foundation, and Moore Trust Scholarship funds.

Objective: The primary intention of the scholarship is to assist students with financial need, who otherwise would not be able to enroll in dual credit college courses during their high school career. The secondary intention is to help as many students as possible based on available annual funding. If funding is limited for the secondary intention, preference will be to help the greatest number of students and/or preference will be to those students who have received less funding previously. The Foundation and Scholarship committee will maintain records of prior funding based on student name, semester, number of credits, and scholarship award to assist with these decisions.

Qualifications: Students must be attending Hiawatha High School and <u>be enrolled in college credits</u> for the upcoming semester at the time of application. Summer course tuition will not be funded at this time. The scholarship will not have a separate qualification for GPA. If the post-secondary educational institution accepts the student's enrollment, the student is eligible for this scholarship.

Financial need: Financial need will be determined by the Redhawk First Steps Scholarship committee members through information available at the USD 415 Board Office, provided that a parent or guardian granted permission to access the Free & Reduced Meal Application on file. The student is also asked to provide a statement on why they have financial need. Statements will be kept confidential.

Stakeholders: The High School Counselor's Office will be responsible for communicating the scholarship opportunity to students and teachers. The Foundation will communicate the scholarship opportunity through local media which may include newspapers, radio, and social media.

 - May 1st for Fall semester enrollment.
 - December 1st for Spring semester enrollment.
- Submit application to the USD 415 Board of Education Office

Scholarship committee: A Redhawk First Steps Scholarship Committee will be formed from members of the Foundation, along with a member of the HHS Counselor's Office and one or more high school educators.
