Schoolcraft Community Schools is applying for Section 23g MI Kids Back on Track which was created to help support programs in public school districts to help address unfinished learning, get students to grade-level academic standards, provide additional academic assistance to students at risk of falling behind their peers, or help high school students prepare for postsecondary education.

Schoolcraft Community Schools will use these funds to enhance evidence based instructional practices to help support students not proficient by state assessment standards. SCS will use fundings to provide additional instructional resources for certified teaching staff and high-qualified paraprofessionals. Additionally, funds will be used to evaluate instructional cycles and data reviews to ensure evidence base practices in tier 1, 2 and 3 instruction.

Program measures will be based on NWEA, M-Step, local assessments, and other diagnostic measures to gauge proficiency in reading and mathematics. All state and federal guidelines and reporting requirements will be met and continuous monitoring will occur.

### Multi Tiered System of Supports - Academic and SE...

*Status:* ACTIVE

*Statement:* Our goal is to develop and implement a Multi-Tiered System of Supports, academic and SEL, for PreK-12th grade students by June 2025.

*Created Date:* 07/01/2021

*Target Completion Date:* 06/30/2025

*Data Story Name:* 21/22 PBIS

*Initial Data Analysis:* SCS's story of SEL support is primarily told and justified by the lack of data available. SCS does not have a documentable Tier I, II, or III system of support for SEL. The district has a social work/student services team in place (as of 2019/20) that has helped identify the need for a program such as PBIS. The administrative team has experience with PBIS in prior roles. The goal at SCS is to tell a different data story by this time next year (2022) by implementing a K-12 system of support for all students related to SEL.

*Initial Initiative Inventory and Analysis:*

What is the connection to the district mission?

"To educate and empower each Eagle in life"

What personnel are involved in the implementation?

Social Workers, Student Service Team, Administrators, Teachers, Support Staff

What is the expected outcome?

Identify and implement a Tier I system of supports across K-6 and 7-12.

What evidence for outcomes are there thus far?

The K-6 and 7-12 schools each have a matrix of expected behaviors in each location of the building. The rest of the district has not started the process of implementing Tier I PBIS.

What is the financial commitment and source of funding?

Using at-risk dollars, support the MTSS efforts of both academic and SEL systems, their implementation, staff training, and student programs.

What fidelity measures exist?

Data meetings at the rate of every 6 weeks ensure that student identification and intervention are fluid and accurately identifying students who are eligible for support.

What professional development exists including coaches and performance feedback?

K-6 is receiving reading and behavioral coaching purchased from KRESA. Additionally, subs for data review days are being purchased to coach staff in data review strategies.

#### *Gap Analysis:*

There is a gap in understanding at all levels of what PBIS is and intended to do.

There is a gap in beliefs in building expectations.

There is a gap in which students get supported and which ones don't (SEL) due to varying classroom/building expectations

There is a gap in the way behaviors are tracked K-12

There is a gap in how student supports are layered and added (No delineated tiered system of support)

#### *District Data Story Summary:*

What strengths have been uncovered? What growth edges have been identified?

A strength of SCS is the passion and desire from the whole staff to support students with documented SEL needs in the district.

What learner needs are going unmet or not being met adequately/sufficiently?

There is not at a fully implemented Tiered System of Support for SEL (PBIS). Implementing a full-tiered system of PBIS would support our students.

What district programs, supports, and services are designated to meet student, classroom, leadership and support priority growth targets needs?

A student service team has been established to support this work.

Are there any major challenges not being addressed by a service, program, or activity?

The major challenge being faced by SCS currently is simply the implementation process. A committee of staff has been identified. Time for that team to do their work and deliver outcomes has been identified which will ensure this team has the ability to meet these goals.

The five essential components include the following: Team-Based Leadership; Tiered Delivery System; Selection and Implementation of Instruction, Interventions and Supports; Comprehensive Screening & Assessment System; Continuous Data-Based Decision Making."

**Summary:** EdTrust defines expanded learning time (ELT) as programs or strategies implemented to increase the amount of instruction and learning students experience. ELT strategies include afterschool, summer, and in-school programs. The evidence suggests that extended learning time programs, including extended school day (ESD), extended school year (ESY), and expanded learning opportunities (ELO) programs that provide academic services during out-of-school time hours, can be effective in improving a range of educational outcomes for students. Findings also suggest that extended learning time programs may be more advantageous for low-income, low-performing, ethnic minority or otherwise disadvantaged students.
