Title I Family Engagement

General Information

- 1. Clearfield Area Elementary will work with parents and families in the development of the Title I Plan on a yearly basis.
- Clearfield Area Elementary will coordinate and provide technical assistance in planning and implementing

 involvement.

Implementation:

- A stakeholder meeting will be held at least twice a year to gain input and discuss items such as consolidated
 application, the Parent and Family Engagement plan, and School-Parent Compact and other Title I
 information.
- Title I Family Nights/Family Engagement activities will be held at least once a year at CAE and be open to all families. Invites will also be shared with non-pub schools.
- Input from stakeholders will be used to plan the Family engagement activities.
- Title I surveys will be sent yearly to evaluate the effectiveness of the parent and family engagement activities.
- Sharing of information through social media (website, Facebook, Remind app) will be done on a regular basis.
- Parent/teacher conferences will be scheduled twice a year and can be held at any time by parental request.
- Parents/guardians will be notified of the annual SPAC conference. Support will be given to parent/guardian who is interested in attending the conference.
- Title I updates will be shared regularly at the CASD monthly board meetings and PTO meetings.
- Best practice ideas and implementation to engage families in their child's education will be discussed and shared at CAES faculty meetings at least once a year.
- CAES will invite community agencies and other support providers to Family Engagement activities to share their information with families.

Agency, Federal, State and local Program Coordination

The CASD will support the Clearfield Area Elementary School with coordinating and integrating parent/guardian involvement with other agencies and programs, including:

- Head Start, Pre-K Counts and other local preschool programs meet and obtain information about incoming Kindergarten students. Provide information on all available early childhood programs to parents as requested and during family engagement nights.
- A representative from the CASD will attend the annual Title I conference and share the information with staff, family and stakeholders.
- Provide information and transitional support to parents and families of students who are interested in attending the Clearfield County Career and Technical Center during their high school years.

• Provide information about programs that are being offered at the Shaw Public Library, Children's Aid Society and other agencies in the area.

Parental/Guardian Assistance
