1 2 CITY OF WESTLAKE, OHIO 3 **ORDINANCE NO. 2025-57:** 4 5 **REDLINED** 6 AN **ORDINANCE SUPPLEMENTING** 7 SUBSECTION 1218.03(h) OF THE ZONING 8 CODE AS TO PERMITTED USES IN 9 **EXCLUSIVE INDUSTRIAL DISTRICTS.** 10 11 12 WHEREAS, Applicant Elise Free has submitted an application to the City for a text amendment to the Zoning Code to add biohacking facilities as a permitted conditional use in the 13 14 exclusive industrial district; and 15 WHEREAS, after careful consideration, the Planning Commission of the City of 16 , 2025, recommended approval of the changes to the Zoning Westlake, on Code specified herein; and 17 18 WHEREAS, pursuant to Article III, Section 13 of the Charter of the City of Westlake, 19 Council provided for and held a public hearing on said Code amendment. 20 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 21 WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO: 22 23 **Section 1:** Subsection (h) "Services, Wholesale Sales and Storage 24 Establishments" of Section 1218.03 "SCHEDULE OF PERMITTED BUILDINGS AND USES" 25 be and the same is hereby supplemented by the enactment of new Subsection (h)(16), which shall 26 read as follows: 27 "1218.03 SCHEDULE OF PERMITTED BUILDINGS AND USES. 28 29 The following schedule enumerates all main, conditional and accessory buildings and uses 30 which are permitted in industrial districts. 31 32 Those buildings and uses which are permitted and regulated as main, conditional and accessory uses in a given industrial district are designated by an "M", "C", or "A", 33 respectively, placed opposite the use and in the columns under the districts in which such 34 35 use is permitted.
