JOB TITLE: Animal Control Officer **DEPARTMENT**: Police Department

GRADE: 2

FLSA STATUS: Non-Exempt

CLASSIFICATION: This classification is a "safety sensitive" position as defined by the United States Department of Transportation drug and alcohol testing regulations, the Oklahoma Standards for Workplace Drug and Alcohol Testing Act and/or Oklahoma Medical Marijuana laws. As a "safety sensitive" classification, you will be subject to drug and alcohol testing, including random testing. Marijuana is one of the substances included in the drug panel screening. Possession of a medical marijuana license will not excuse you from the testing process, or the consequences of testing positive for marijuana.

POSITION SUMMARY: Reports to Chief of Police via Chain-of-Command. The Animal Control Officer position is responsible for enforcing local, state and federal laws regarding animal control and animal cruelty.

SUMMARY OF ESSENTIAL DUTIES:

- Investigates reports or complaints of dogs, cats, or other animals creating n Investigates reports or complaints of dogs, cats or other animals creating nuisances; investigates reports of animal abuse; investigates animal bite cases, and sees that necessary tests on quarantined animals are done to test for rabies.
- Enforces City animal control and licensing laws that include the issuance of warnings and citations for violations to the same.
- Patrols city streets and roads in the assigned vehicle; searches for stray and other domestic animals and livestock.
- Collects, impounds, quarantines and disposes of animals as needed
- Provides public education.
- Cleans and maintains the animal control vehicle and cages used to detain animals. Feeds, waters, and cares for impounded animals.
- Reports fees to the City Clerk's office for licenses, violations and adoptions; maintains the necessary records of transactions.

- Cleans and maintains area in and around the dog pound.
- Prepares and maintains daily, monthly and annual reports and records on all pound activities. Work is subject to periodic review and supervision by the Chief of Police and/or his designee.
- Answers telephone at the animal shelter and assists visiting citizens.
- Performs other duties and assists other City departments as required.

MINIMUM QUALIFICATIONS:

Applicant must have the following qualifications:

- Knowledge of various breeds of domestic animals, their specific behaviors and procedures for dealing with them and the public.
- Ability to enforce animal regulations and ordinances and ability to learn local and state laws relative to animal control.
- Ability to communicate orally and in writing.
- Ability to safely and effectively use firearms, tranquilizer weapons and other traps for animal control purposes.
- Ability to deal with irate or emotional individuals relative to pets and stray animals, etc.
- Possess verbal perception, motor coordination and manual dexterity.
- Ability to follow oral or written instructions, operate tools and machinery safely and perform manual labor.
- Ability to operate a two-way radio.
- Ability to exterminate animals or assist veterinarian in euthanasia as required and dispose of carcasses.
- Ability to work independently and perform minor maintenance on the City's vehicle.
- Ability to read, understand and communicate fluently in the English language.
- Must possess a valid Oklahoma driver's license and possess driving record acceptable to City's insurance carrier.
- Must reside within ten miles of the City limits of Guymon.
- Must be 18 years of age or older.
- Must have a high school diploma or equivalent.
- Must be able to pass background screening.
- Must be able to pass drug/alcohol screening.

WORKING CONDITIONS/PHYSICAL REQUIREMENTS:

Applicant must be able to meet the following working conditions and physical requirements:

- Must be able to lift up to 50 pounds on a routine basis and lift, push, pull, and carry objects of 100 plus pounds on a frequent basis.
- Will be exposed to personal danger relative to diseased, injured or unfriendly dogs and other domestic animals or small wild animals.
- Exposed to extreme weather conditions
- Willing to periodically work stand-by and callback duties and work overtime as needed.

- Willing to wear a uniform and maintain a neat personal appearance.
- Subject to working around obnoxious odors and conditions.
- Willing to pick up dead animals from streets and private properties, when requested and transport said animal to a predetermined locations for disposal.
- Willing to be on 24 hour call and to work various hours.
- Subject to noise, frequent interruptions, work under stressful situations, etc.
- Operates a vehicle for extended periods of time in all environmental conditions.
- Must have the physical strength and stamina to be able to pursue on foot and subdue animals that are at-large.
