The following items will be reviewed and presented as information and/or recommended for approval by the Board at this meeting. There is also a consent agenda of separate items available to view online.

# Annual Organization Meeting - Election of Officers

Each year in December, the Board of Trustees holds an organizational meeting. At this meeting they elect a President and a Clerk. They appoint a Secretary and approve a calendar of regular meeting dates, times, and places for the 2024 calendar year. They also designate board members to various committees. Recognition is given to the outgoing president.

## **Discussion/Action Items**

The School Plans for Achievement (SPSAs) will be submitted to the Board for review and approval. All three site principals will be available for questions.

**The First Interim Budget 2023-2024** will be presented by Chief Business Official Daniel Ornelas to the Board for review/approval.

The Second Reading of Board Policy 6146.1 High School Graduation Requirements will be up for any additional discussion and then probable approval.

**Employee and Visitor Identification Badge Policy** - School Safety best practices includes recommendations that employees and visitors on campus wear an identification badge. This new policy will be reviewed and discussed.

**J-13A Waiver for Allowance of Attendance** - The recent Aromas fire necessitated closing school at Aromas for that day. This waiver paperwork is required by the state as part of a process including our request that Aromas does not have to make up an extra day of school.

### **Board Policy 3100- Reserves - Discussion**

At the recent Budget Advisory Committee Meeting, those board members in attendance requested a full board discussion on BP3100 which designates 17% for reserves. The Board will discuss options and make possible recommendations about any needed revisions.
