Call to Order - Mrs. Edgerle, Board President, called the meeting to order at 7:00 p.m. at the District Office. Board members and visitors recited the Pledge of Allegiance.

BUSINESS ITEMS

Gifts/Grants Mr. Rush moved to accept the following grants/gifts: ProStart Professional Development Educator Grant \$2,000 for Mandy Burger PD opportunity; True Value Foundation 20 gallons of paint; and Oneok \$2,669.50 for robotics program. Mrs. Bohl seconded, motion passed 5-0.

FBLA Supplemental After a presentation by Karl Dawn Stover and Cursstyn Browning, Mrs. McGowan moved to add Future Business Leaders of America to our supplemental contract list. Mr. Rush seconded, motion passed 5-0. During the negotiations process, the compensation for this position will be determined.

ECLC Transportation Ellsworth Childcare and Learning Center is requesting transportation for EES students from EES to the center for the after school program, with compensation of \$2,000. Mrs. McGowan moved to approve the transportation request by ECLC for 24-25 year. Mr. Rush seconded, motion passed 5-0. The center will also continue to provide a bus attendant for supervision.

FSMC addendum renewal Mrs. McGowan moved to approve the 2024-2025 OPAA! addendum as presented with a CPI increase of 2.5% per meal. Mr. Rush seconded, motion passed 5-0. After discussion, Mr. Rush moved to keep all meal prices constant for the 24-25 year. Mrs. Bohl seconded, motion passed 5-0.

Out of State Travel Mr. Rush moved to allow out of state travel for a professional development opportunity for Mrs. Burger this summer. Mrs. Bohl seconded, motion passed 5-0. Travel will be to New Orleans for the National Restaurant Association Educational Foundation professional development. Expenses are covered by a \$2,000 grant and Perkins funding for PD.

Data discussion Mr. Magie presented FastBridge testing information from fall and winter. The data indicates the district is moving in the right direction. Mr. Magie will be at the June meeting to present the spring data. This is part of the district needs assessment process for KESA 2.0.

Policy - second reading It was moved by Mrs. McGowan and seconded by Mr. Svaty that the board adopt on second reading recommended revised, deleted, and new board policies as presented. Motion passed 5-0. Policies approved: EBBB, EE, GARIA, GARID, GCIA, JBH, JDDAA, and JGFGBA. Copies are attached.

School handbooks Updates were presented for the high school handbook. After discussion, the updates were tabled till the June meeting. Mrs. Hilbig will survey the certified staff regarding the cell phone usage and what they would like to have.

School start and end times In order to equalize start and end times for each building, and address some supervision issues, the board discussed changing those times. Mr. Rush moved to approve the adjustment to the start and end times for KMS and EJSBS as presented. Mrs. Bohl seconded, motion passed 5-0. Starting in 24-25, all buildings will start at 8:00 a.m.; EES will end at 3:05 pm, and KMS and EJSBS will end at 3:00 pm.

Transportation Mrs. McGowan moved to increase the district's reimbursable mileage rate to the state rate of \$.655/mile effective immediately. Mr. Svaty seconded, motion passed 5-0. This will give the district more regular route expenses to offset the loss in state aid in transportation.

KASB membership Mrs. Edgerle moved to renew district membership with KASB, including the legal assistance portion for \$13,190.49. Mrs. McGowan seconded, motion passed 5-0. KASB provides an invaluable service to school districts, and will provide all our legal services for 24-25.

Open Enrollment/Nonresident Mrs. Hilbig presented enrollment projections, including current nonresident students, and provided anticipated open seats. The application process will be June 1-30, with students notified in July. Nonresident thresholds were approved in October. Mr. Rush moved to approve the USD 327 student enrollment projections and the nonresident enrollment capacity as presented by Mrs. Hilbig. Mr. Svaty seconded, motion passed 5-0.

Calendar Mrs. Edgerle moved to approve the 24-25 calendar as amended, to change the teacher work days from what was presented in the initial calendar. Mr. Rush seconded, motion passed 5-0. NEA has partially ratified the negotiated agreement to make this adjustment, removing references to specific months, and instead allowing the work days to be scheduled in conjunction with the school breaks.
