## Facilities Scheduling USER GROUP PRIORITY CLASSIFICATION

- Group 1. MSD Business – all school district business and athletics**
- Group 2. MSD Affiliated Non-Profit Groups** (Such as: PTA/PTSA, MCEP, School Booster Clubs, Marysville Special Olympics, MSD affiliated union groups and foundations)
- Non-Profit groups affiliated with the Marysville School District whose purpose is to support the mission of the school district.
- Group 3. Non-Profit: Local Youth Organizations, Educational Programs, Local Service Organization Meetings, and Local Adult Recreational/Sports Groups** (Such as: Boy Scouts, Camp Fire, Girl Scouts, Msvl AAU, Msvl Little League, Msvl Youth Football, Msvl Youth Soccer, Msvl Youth Wrestling / Home Owner Assoc. Meeting, Msvl-Tulalip Chamber of Commerce, City of Marysville, Maryfest, Msvl Kiwanis, Msvl Rotary, Adult Program Meetings, YMCA)
- Group 3A:**
- Local Youth Organizations must have open enrollment and open participation for all ability levels and participants reside within the Marysville School District boundaries. Youth Organizations wanting to be classified under Group 3 are required to complete and submit additional youth documentation forms along with Facility Use Application
  - Non-Profit groups holding a meeting whose main purpose is to promote the welfare of youth or adults within our local community.
- Group 3B:**
- Youth Organizations whose participants are selected on a competitive or tryout basis and whose activities are not open to youth of all ability levels and 80% of the participants reside within the Marysville School District boundaries.
  - Local Adult Recreational/Sports Groups.
- When an above classified user group is hosting a revenue generating event Group 4 rates will apply.*
- Group 4. Non-Profit Community Organizations (Youth & Adults) Hosting an Event and Local Individual Users** (Activities for which public halls or commercial facilities generally are rented or owned, such as: religious organization holding religious services/studies, receptions, community fundraiser, political rallies, memorial services, entertainment events)
- Organizations charges admission, collects an offering or donation, or sells merchandise (other than to off-set activity/meeting costs)
  - Other non profit organization who do not fall into Group 3
  - Individual community members
- Group 5. Profit Oriented Groups and Groups/Individuals Out of District Boundary Service Area**
- Commercial and for-profit businesses or entities
  - User group applicants whose address falls outside or organizations whose participants reside primarily outside the Marysville School District Boundaries.

**Governmental entities with an inter-local agreement or designated program partnerships on file with Marysville School District will be charged according to that agreement.**

**Facility Use Auxiliary Fees charged to a user group will be determined by the Facilities Scheduling Department.**
