- Each teacher monitors individual student assessments of every student via iStation, DIBELS, and Teacher Observations. These results are shared with parents at parent/teacher conferences as well as regular progress update communications.
- ACT Aspire Summative Assessments are given annually in grades 3 and up. Students are expected to meet the readiness levels of "Exceeding" or "Ready"
- O DMJ offers Gifted and Talented Enrichment opportunities
