  - **Food Service Update/Sharla Porter from Aramark & Stacey Stacey Proctor presented.**
    - **Lucky Tray day at the Primary Campus and if you have the lucky sticker on your tray you earn a prize.**
    - **Special food days offered monthly (Greek, Chinese, etc.).**
    - **Taste the Rainbow night for parents coming soon. November 14th JH night sponsored by the Texas Ace Grant.**
    - **All campus Thanksgiving meals are coming up as well as the Senior Citizen luncheon (Nov. 16th) at RHS at 11:30 am.**
    - **100% passing rate for Health Inspections at all campuses.**
  - **Campus Safety/Traffic Issues/Abel Sanchez-**
    - **THC gummies (empty wrapper found at JH campus) are to be treated as a vape- MIP. If a gummy would have been found it would have been a third degree felony. Unfortunately it is sold at the Vape store in Robinson.**
    - **Traffic and buses have been moving smoothly. Fourth grade side at RIS will need to be coned off to prevent illegal turning and holding up Old Robinson Rd.**
    - **Lindsey Richard- VOICE (Viable Options in Community Endeavors)- Education program to teach better choices which helps to reduce number of days required in DAEP. Some students are requesting to**

stay in the program even after their time at DAEP is completed.

- Safety/David Wrzesinski-
  - TEA door audit failed at HS Campus. Additional training required and completed
  - Threat assessments are higher now than in years past. Other schools are averaging 2-3/week but we are more active from Robinson Elementary and up. The campus with the least amount of threats currently is the RHS. These are not severe, mainly kids saying inappropriate things, we are assisting these cries for help.
  - Federal Grant to get AI generated weapons detection (match grant so we pay part) and we were 1 of 11 in the state to receive the grant. System has a similar metal detector look but does not have to be manned and is portable.
  - Students and visitors just walk through the unit, no beeping or lights, but if alerted it will immediately be sent to Abel, Admin., David, secretary at doors, etc. We can get people together before we let them into the building. It can detect vapes, weapons, knives, but not keys, laptops, etc. RPS, RES at main entrance. RIS/RJH will have 2 entrances covered. RHS will have 3 doors covered. We are the only public school in the State of Texas to have this currently. We will try to have this in place after Christmas Break. These can run off batteries or plug if needed.
