





Community-Wide Emergency Response Training Exercise in Columbus set for April

After nearly two years of extensive conversation and planning, numerous Columbus area agencies are coming together for an Emergency Response Training Exercise in order to be better prepared in the event of an emergency.

Platte County Emergency Management is spearheading the exercise in collaboration with the **Columbus Police** Department. Platte County Sheriff's Office, Columbus Fire Department, Columbus Public Schools, Columbus Community Hospital, East Central District Health Department and Columbus City Hall.

The exercise will take place beginning at noon on Friday, April 19, 2024, at Columbus High School, 3434 Discoverer Drive – a day in which CPS students are not in school. The exercise itself will take place from approximately 33rd Avenue to 41st Avenue.

"I'm excited to see everyone working together toward a common training goal," Platte County Emergency Manager Tim Hofbauer said. "All those involved in the planning and participating in these exercises have invested a lot of time and are truly invested in the safety of the community."

Columbus Police Chief Charles Sherer emphasized the importance of the training exercise.

"No one wants to think a situation like this could happen in our community; however,

as situations across the country have shown us, no one is exempt. These situations can occur anywhere, in any size community," Sherer said. "In order for local law enforcement to prepare for events such as this, it is necessary to undergo this type of training to show our preparedness; both our strengths and our weaknesses." The Local Emergency

Planning Committee made of representatives from the aforementioned agencies began this process in Summer 2022 with monthly meetings that also saw tabletop exercises completed in Fall 2022 and Spring 2023.

During the April 19th training exercise, volunteer actors will be role players. Emergency Management is coordinating the exercise, while local law enforcement agencies will work to contain the threat. The Columbus Fire Department will handle treating and transporting victims, while Columbus Public Schools will focus on its emergency response and reunification. Columbus Community Hospital will treat victims who are brought in for emergency care.

"We don't want to be inventing a process in real time," said Dr. Mark Howerter, the hospital's chief medical officer. "Our goal is to practice, troubleshoot and perfect so if this ever does occur, we have processes in place and know we can be as efficient as possible. We want to test our ability to respond to a mass casualty incident and be prepared for an event like this."

Those involved praised the collaboration among the agencies.

"This is an amazing group. We all have a part to play and the collaboration has been outstanding," Columbus Police Capt. Doug Molczyk said. "All of the agencies involved with this exercise practice and train for worst-case scenarios. It is exercises like this one where we combine all our independent training into one. We need to know how to work together as a team and that is one of the goals of this exercise."

WHAT'S **PROPOSED?**



On March 1st, the Columbus Public Schools Board of Education approved a facilities bond referendum in the amount of \$26 million based on results of voter surveys, a community town hall meeting and the effects that LB 878 could have on our growing school district. The vote will take place on May 14th.

WHAT'S PROPOSED? •

- Safety and Security Improvements in the District's existing buildings and facilities
 - Bullet resistant window coverings
 - Security camera updates
 - Secure and controlled entrances
- Additions and improvements to existing elementary buildings to include dining areas and kitchens at Centennial, Emerson, North Park and West Park.
- Addition and improvements to the existing middle school building to include a classroom addition and remodeling of dining facilities.
- Providing for the necessary furniture, equipment and apparatus for such additions, renovations and improvements.

THE PROPOSED PROJECTS WILL:

- Will meet the immediate facility needs of Columbus Public Schools.
- Will address safety and security needs across all district buildings.
- Will expand eating and kicthen preperation areas at four elementary schools where they are not large enough to accommodate the student population.
- Will expand CMS dining areas to accomodate 1,200+ students. The current space is designed for 800 high school students.
- Will relieve overcrowded classrooms at Columbus Middle School.

A bond is a State-approved funding process for a set scope of projects.

When voters approve a bond proposal, the school district sells bonds in the authorized amount and uses the proceeds of the sale to pav for those projects in the bond proposal.

BONDS CAN BE USED FOR:

- Construction of new school buildings or additions to existing school buildings.
- Land purchases as well as site development and improvements.
- Purchase loose furnishing, equipment and some technology purchases.
- Remodeling existing school buildings.
- Playground development and improvements.

BONDS CANNOT BE USED FOR:

- Salaries and service contracts.
- Portable classrooms for temporary use.
- Textbooks.



Three move forward for interviews, Board of Education to decide by month's end

On Monday, March 4, 2024 the Columbus Public Schools Board of Education met with Consultants from McPherson & Jacobson to review candidates for the position of Superintendent for Columbus Public Schools. By unanimous approval, three names were moved forward for interviews to be held on March 20th and March 21st.

DR. DEVIN EMBRAY

Dr. Embray began his teaching career at Montezuma Community Schools and Knoxville Community Schools in Iowa. . He began his administrative career at Fort Dodge

Community Schools as an assistant principal.

Other administrative positions include principal and assistant superintendent at West Delaware County Community Schools, superintendent at Independence Community Schools and is

currently the superintendent at Glenwood Community Schools since 2010. Dr. Embray is married to Angie and they have three grown children and one in college.

DR. VERN FISHER

Dr. Fisher began his teaching career at Oakland-Craig High School. From there Dr.

Fisher spent the next twelve years in teaching and administrative positions in several school districts in Texas.

Dr. Fisher served as a principal in the Van and Jacksonville Independent School Districts.

In 1998, Dr. Fisher

returned to Nebraska and became principal at Beatrice Middle School and then Lincoln Northeast high school.

Dr. Fisher also served in central office positions in Lincoln Public Schools and Grand Island Public Schools.

Dr. Fisher was the Superintendent at South Sioux City and is currently at Gibbon Public Schools.

Dr. Fisher is married to his wife Tracy and

holz echoed that sentiment.

"It is very clear that members of all groups have and want to create safe learning environments for all schools within our community. This drill is an opportunity to train schools, fire and rescue and law enforcement to appropriately respond to a crisis we all hope and pray does not happen in our community," Loeffeholz said. "If it does, the data and what we learn will help us respond to serve the people we are responsible for."

Platte County Sheriff Ed Wemhoff said having all of the area agencies involved collaborate and prepare for a "what if" situation is paramount to serving its citizens properly.

"I believe that if you are not learning you are failing, and although this event has already taught us a few things, we still have more to learn. As Platte County sheriff, I believe it is imperative to plan for events that I pray to God never happen," Wemhoff

said. "History and data will show that people fall back on training during highly stressful situations, which is why we need to train for incidents such as this. We need to train in these types of situations to better prepare ourselves to be effective in protecting the citizens we have sworn to protect."

The April training exercise comes after a similar drill was conducted involving area agencies back in September 2019 on the Central Community College-Columbus campus.

Sue Deyke, the hospital's emergency room director, called the process of planning this drill "amazing," noting Columbus Mayor Jim Bulkley has also attended the meetings.

"We're invested in this," Deyke said. "Heaven forbid this ever happens, but we would know what (other agencies) are doing. And it is tremendous to have that kind of support.

The second part of this bond issue will be to improve and update the kitchens and dining areas of four of our elementary schools.


Currently our kitchens are outdated and not large enough to keep up with our growing student population or the ability to serve over 13,000 meals during the summer lunch program. This program includes all children within our community.

The third part of this bond proposal is to add 12-14 classrooms to our existing middle school and expand our dining area to serve 1,200 students.

Communication Methods



Direct Mail

One way communication used by CPS District and School Buildings to families.



Thrillshare

One way communication used by the CPS District and School Buildings to families for text messaging and automated calls. Every parent/guardian is automatically included. If you change a phone number, address or email be sure to contact your school as well as update your profile in ParentVue.



EduTrack (Wordware)

One way communication used by school building food service staff to communicate outstanding account balances. This may be text messages, automated calls or email.

ParentVue

NEW parent portal that replaces PowerSchool. You will have access to grades, attendance and other data about your child or children. You will be able to see records for all of your children with this single log in. Log in directions will be mailed to your home.

Remind

Two way communication that allows for texting and phone calls. Used by teacher and activity sponsors without exchanging phone numbers. Provides safety for you, your student and staff as all text messages are archived. You MUST OPT-IN. You do not need a smartphone; you can sign up with an email address as well. An activation code is needed. Teachers will provide this code to you using either Google Classroom or SeeSaw. Prior to your teacher contacting you please download the REMIND app. On Apple and Android devices, go to your app store and search Remind: School Communication.

Google Classroom

Used by high school and middle school students. Each teacher sets up a virtual classroom for each class section. This is optional for parents/guardians. This is where students see assignments, due dates, and general class information. You can receive regular summaries from Google about your student's work. To join, email your student's teachers and ask to be invited to Classroom. This will add you to all of their classes. Be sure to include your student's name and student id number.

Seesaw

Smore

Used by elementary students and parents/guardians. Each teacher will set up a class within this platform and communicate to you how to access your student's information. This is optional for parents/guardians. This is where you and your child will receive and complete assignments.

Email

All staff members may be contacted by email. Email addresses can be found online at each school's website.

One way communication tool used by the district and principals to send newsletters or alerts via email.
