Hankins Property: The title work is almost completed. Mr. Crank needs authorization from the school board to be able to sign for the property, this is required by the title company.

Bus Barn: Ameren has installed the new service for the bus barn. H.E. Mitchell is working on finalizing the garage doors installation.

Basketball Goals and Pads: Sports Con the company who is installing the new basketball goals and wall pads were here on the 15<sup>th</sup>. They took additional measurements. This will not be able to be completed this ball season.

Audit: FY23 audit is completed. There were no findings in the audit and no indication of any type of fraud. We received the highest financial ranking we could receive.

High School Stage Curtains: A estimate from our measurements for new flame retardant curtains for the high school stage was \$10,000. We will have them come measure and give us the final cost.

Pediatrician on Teledoc (Dr. Reddy): Dr. Michael Shiffano and Dr. Reddy are offering to equip our school with technology that will allow Dr. Reddy, his staff, and parents to see students remotely. There was discussion to see if we could have a local clinic set up and see students. The details are not complete but we will know more at the next board meeting.

Galatia 5-year Draft Plan: There was a discussion on the next five-year upgrades to the school facilities.

#### **COMMITTEE REPORTS:**

#### TRANSPORTATION:

Bus #14: The bus is going to Cummins to have the injectors repaired/replaced.

Bus #16: Bus #16 is our new bus with a lift was delivered on November 21, 2023. As soon as we install a new CB radio the bus will be on a route.

Bus #11: The bus door has been replaced with a manual door opener and it works well.

Bus #9: The exhaust manifold is scheduled to be repaired.

#### ATHLETICS:

Basketball Season: High school boys' and girls' basketball season is underway. The junior high boys and girls basketball is halfway through their season.

#### OLD BUSINESS:

Solar Project: We have two companies that are working on giving us a quote for the solar project. One company is proposing a power purchase agreement with zero cost to the district. This will not eliminate our electric bills but will lock in a rate for twenty-five years for the junior high/high school building. The other company is working on a quote that includes a grant that they will write to receive forty percent back on the expense. More information will be provided at the next board meeting.
