- 1. Superintendent's Report
  - a) United Way Adopt a Student Campaign Mr. Fry shared the upcoming United Way drive the district will participate in from September 30-October 31. Each year the district sets a goal of \$5000 in funds raised with many of those dollars committed to the "Adopt-a-Student" fund that supports CPPS students
  - b) Rural Library Update Mr. Fry shared an update from the WW Rural Library regarding the 2acre plot of land next to the CPHS tennis courts. The library is pursuing a library space in the new building at Lion's Park and is not open to selling the entire lot to the district at this time. They will meet again and consider subdividing the area for sale
  - c) Facility Use Form Update Mr. Fry reviewed changes to CPPS District Facilities fees. The fees had not been adjusted since 2019 and needed to be adjusted for inflation (increase in utility, insurance, and personnel costs)
  - d) Ag Science/FFA Update Mr. Fry gave a report on the timeline for the opening of the Agriculture Science opening at CPHS. The position was vacated late in the summer leaving a hole that impacted students in the associated classes and FFA. The district will work with the community to identify wants and needs for the position and fill it permanently for the 24-25 school year. An FFA Advisor and Ag. Science teacher (one section) have been hired for the current year to keep all interested students engaged. CPHS will hire a great teacher to join its amazing staff.

  - a) Davis Elementary: Mark Ferraro shared about the attendance incentive program the staff came up with to encourage 100% student attendance.
  - b) Sager Middle School: Chris Plucker shared about the progress of the new year in implementing SOAR, new ASB leadership, and the overall successful start through September. Mr. Plucker shared about the upcoming Hispanic Heritage month activities and the excellent learning taking place in classes. year.
  - c) CPHS: Robert Aguilar and Ambra Bryant shared about the focus on SIOP in each class, the math department pilot of Carnegie math and the great math dialogue going on in classrooms. Mr. Aguilar gave a shout out to the new staff members and new ASB club advisors. Next week is filled with Homecoming activities.
