- a) Mr. Fry shared that the 2019 Discrimination Complaint monitoring has been completed. This involved a number of items that the District needed to deliver to OSPI so they could determine compliance and the District's meeting of the requirements. The District implemented processes and improved others to support all in College Place Public Schools.
- b) Mr. Fry talked about the "Department of Ecology Zero Emission School Bus Grant" that the District will pursue in the new year to begin to electrify its fleet and add infrastructure to support charging.
