We are excited to offer your child the opportunity of Dual Enrollment during summer and fall semester of the 2024-2025 school year. Dual Enrollment registration day is for the current 10<sup>th</sup>-12<sup>th</sup> grade students.

10<sup>th</sup> grade students who enroll with GSW & SGTC taking core classes will have to meet the Zell Miller scholarship testing requirements. 10<sup>th</sup> grade students are eligible to take only CTAE classes at SGTC by meeting the required Accuplacer/SAT/ACT/PSAT score requirements for that program. Current 11<sup>th</sup> and 12<sup>th</sup> grade students are required to meet the minimum GPA requirement and have already taken and passed two English and two math classes.

Monday, March 11, 2024, we will be hosting Dual Enrollment registration day for GSW at Schley County High School. Students are required to select an available time and sign up in the front office by Monday, March 4, 2024. Students wishing to participate in the Dual Enrollment program must have met all the registration requirements prior to Dual Enrollment registration day, March 11th.

**Thursday, March 7, 2024,** we will be hosting Dual Enrollment registration day for **SGTC** at Schley County High School. Students are required to select an available time and sign up in the front office by Thursday, February 29, 2024. Students wishing to participate in the Dual Enrollment program must have met all the registration requirements prior to Dual Enrollment registration day, March 7<sup>th</sup>.

Registration will begin at 8:00 AM and will end at 2:00 PM on the days listed above. Students who have not met the minimum requirements prior to the dates listed will not be eligible for classes during the summer/fall semester of the 2024-2025 school year. Students who do not register for classes on Dual Enrollment registration day will also not be eligible for classes during the summer/fall semester of the 2024-2025 school year.

Parents are welcome to accompany their child as they register for classes. Please feel free to contact me with any questions you may have, and we look forward to an exciting and busy Dual Enrollment registration day at Schley County High School.
