Materials and services will be readily available for our teachers to meet the needs of ALL students both in their academic needs and their social, emotional, and mental health needs.

Training for staff will consist of PPE materials, cleaning and sanitizing instructions to implement CDC guidelines.

Additional chromebooks have been purchased for students to use on-site and for digital learning when needed. Hot-spots to provide connectivity have been purchased and are available when the need arises for students to be able to continue learning services.

Training on the technology and programs students will be using will be held for parents and students as needed.
