## Time commitment

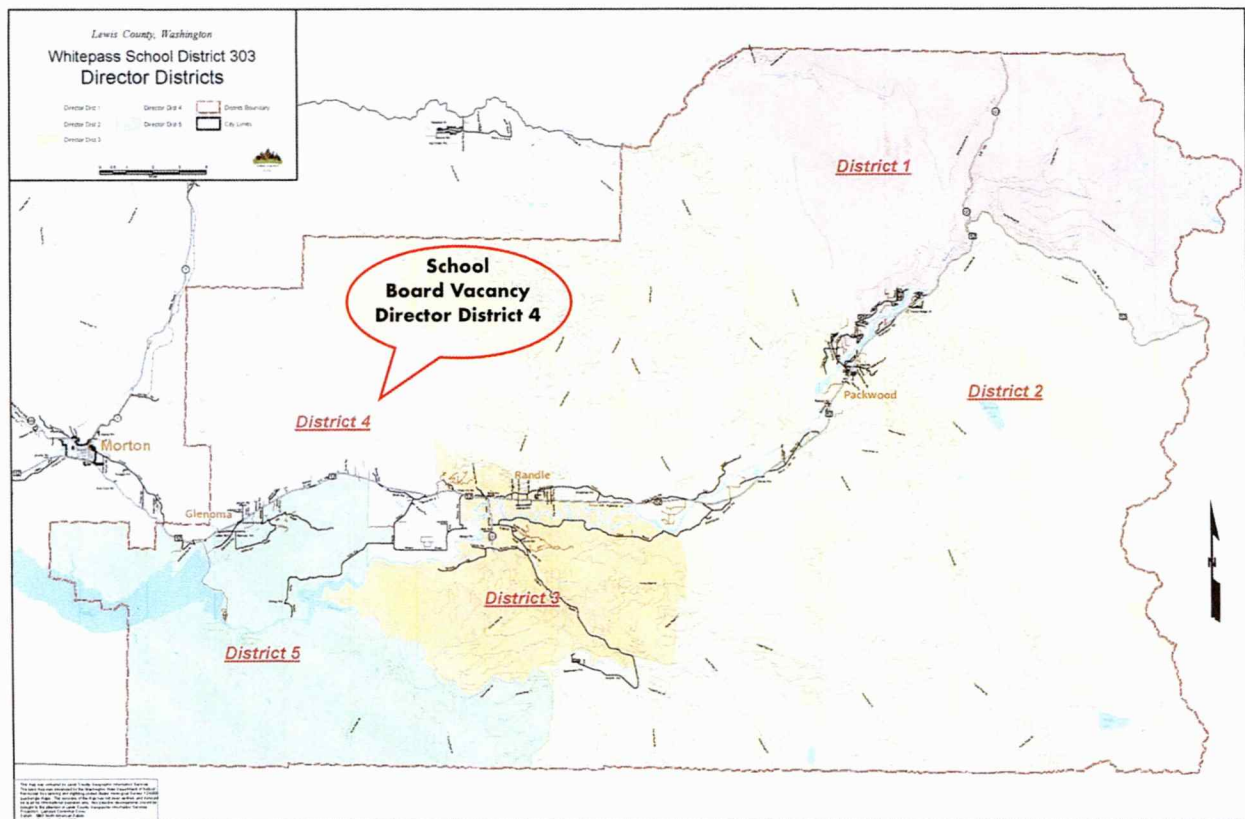
Board members are expected to attend regular meetings on the third Monday of most months at 6 p.m., as well as special meetings and work sessions.

## DIRECTOR DISTRICT #4

That portion of School District 303 described as follows:

Beginning at the NW corner of section 30 Twp. 14 N. Rge. 7 E, being a point on the north boundary line of School District 303; thence westerly along the north line of sections 25, 26, 27, 28, 29, and 30 Twp. 14 N. Rge. 6 E, to the west line of said township; thence southerly along the west line of said township to the south line of said township; thence westerly along the north line of section 6 of Twp. 13 N. Rge. 6 E. to the west line of said township; thence (leaving the school district line) southerly along the west line of said township to the south line of said township; thence easterly along the north line section 6 Twp, 12 N. 6 E. to the NE corner of the NW <sup>1</sup>/<sub>4</sub> of said section; thence southerly along the center line of sections 6, 7, and 18 to the south line of section 18; thence westerly along the south line of section 18 to the west line of said township; thence southerly along the west line of said township to the south line of said township; thence continuing southerly along the west line of Twp. 11 N. Rge. 6 E. to the south line of said township being also the south line of the both county and the school district; thence easterly along the county line to the SW corner of section 31 Twp 11 N, Rge. 7 E; thence (leaving the county line and school district line, and following the west line of Director District #3) northerly along the west line of sections 31, 30, 19, and 18 to the NW corner of section 18; thence easterly along the north line of section 18 to the NE corner of the NW <sup>1</sup>/<sub>4</sub> of said section; thence northerly along the center line of sections 7 and 6 to the north line of Twp, 11 N. Rge. 7 E.; thence continuing northerly along the center line of sections 31, 30, 19, 18, 7, and 6 Twp. 12 N, Rge. 7 E. to the north line of said township; thence continuing northerly along the center line of sections 31, 30, 19, 18, 7, and 6 Twp. 13 N. Rge. 7 E. to the north line of said township; thence westerly along the south line of section 31 Twp. 14 N. Rge. 7 E. to the SW corner of said section, thence northerly along the west line of sections 31 and 30 to the NW corner of section 30 and the point of beginning.
