Fund balances as of November 30, 2022: Education: \$2,972,567, Operation and Maintenance: \$228,157, Transportation: \$430,770, and Working Cash: \$138,592. The four Major Fund Balances: \$3,770,086 Total Fund Balance for all funds: \$4,491,488.

The district has \$98,105 more this year compared to last year in the four major funds. In addition, the district has \$124,845 more this year compared to the previous year in total fund balances.
